Mr. CRAPO introduced the following bill; which was read twice and referred to the Committee on Health, Education, Labor, and Pensions

A BILL

To amend the Elementary and Secondary Education Act of 1965 to improve provisions relating to initial teaching experiences and alternative routes to certification.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. STATE ACTIVITIES.**

4 Section 2207 of the Elementary and Secondary Edu-
5 cation Act of 1965 (20 U.S.C. 6647) is amended—

6 (1) in paragraph (12), by striking “; and” and
7 inserting a semicolon;

8 (2) in paragraph (13), by striking the period
9 and inserting a semicolon; and

1 (3) by adding at the end the following:

2 “(14) carrying out programs that include sup-
3 port during the initial teaching experience, such as
4 mentoring programs that—

5 “(A) provide mentoring to beginning teach-
6 ers from veteran teachers with expertise in the
7 subject matter that the beginning teachers will
8 be teaching;

9 “(B) provide mentors time for activities
10 such as coaching, observing, and assisting the
11 teachers who are mentored; and

12 “(C) use standards or assessments for
13 guiding beginning teachers that are consistent
14 with the State’s student performance standards
15 and with the requirements for professional de-
16 velopment activities described in section
17 2210(b)(2); and

18 “(15) carrying out programs that establish, ex-
19 pand, or improve alternative routes to State certifi-
20 cation of teachers for highly qualified individuals
21 with a baccalaureate degree, including mid-career
22 professionals from other occupations, paraprofes-
23 sionals, former military personnel, and recent college
24 or university graduates with records of academic dis-

1 tinction, who demonstrate the potential to become
 2 highly effective teachers.”.

3 **SEC. 2. ALTERNATIVE ROUTES.**

4 Section 2207 of the Elementary and Secondary Edu-
 5 cation Act of 1965 is amended—

6 (1) by inserting “(a) ACTIVITIES.—” before
 7 “Each State”; and

8 (2) by adding at the end the following:

9 “(b) COMPONENTS OF ALTERNATIVE ROUTES TO
 10 STATE CERTIFICATION PROGRAMS.—To the extent appro-
 11 priate, programs carried out under subsection (a)(15)
 12 shall—

13 “(1) include strong academic and teaching-re-
 14 lated course work that provides teachers with the
 15 academic subject knowledge and teaching knowledge
 16 needed to help students meet State content stand-
 17 ards;

18 “(2) provide intensive field experience in the
 19 form of an internship, or student teaching, under
 20 the direct daily supervision of an expert, veteran
 21 teacher; and

22 “(3) provide that, before entry into teaching,
 23 candidates shall be fully qualified.”.

1 **SEC. 3. DEFINITIONS.**

2 Section 2402 of the Elementary and Secondary Edu-
 3 cation Act of 1965 (20 U.S.C. 6702) is amended—

4 (1) by redesignating paragraphs (1) through
 5 (4) as paragraphs (2), (5), (6), and (3) respectively;

6 (2) by inserting paragraph (3) (as so redesign-
 7 nated) after paragraph (2);

8 (3) by inserting before paragraph (2) the fol-
 9 lowing:

10 “(1) the term ‘beginning teacher’ means an ed-
 11 ucator in a public school who has not yet been teach-
 12 ing 3 full school years;”;

13 (4) by inserting after paragraph (3) (as so re-
 14 designated) the following:

15 “(4) the term ‘mentoring program’ means a
 16 program to provide professional support and devel-
 17 opment, instruction, and guidance to beginning
 18 teachers, not including a teacher or individual who
 19 begins to work in a supervisory position;”;

20 (5) in paragraph (3) (as so redesignated), by
 21 striking the period and inserting a semicolon;

22 (6) in paragraph (5) (as so redesignated), by
 23 striking the semicolon at the end and inserting “;
 24 and”; and

- 1 (7) in subparagraph (E) of paragraph (6) (as
- 2 so redesignated), by striking “; and” and inserting
- 3 a period.
