A BILL

To amend the Federal Water Pollution Control Act to exempt agricultural stormwater and silviculture operation discharges from the requirement for a permit under the national pollutant discharge elimination system, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Timber and Agri-
- 5 culture Environmental Fairness Act".

1	SEC. 2. EXEMPTION FOR AGRICULTURAL STORMWATER
2	AND SILVICULTURE OPERATION DIS-
3	CHARGES.
4	(a) In General.—Section 402(l) of the Federal
5	Water Pollution Control Act (33 U.S.C. 1342(l)) is
6	amended by adding at the end the following:
7	"(3) AGRICULTURAL STORMWATER DIS-
8	CHARGES.—The Administrator shall not require a
9	permit under this section, nor shall the Adminis-
10	trator directly or indirectly require any State to re-
11	quire such a permit, for discharges composed en-
12	tirely of agricultural stormwater discharges, includ-
13	ing stormwater runoff from—
14	"(A) cultivated crops;
15	"(B) pastures;
16	"(C) rangeland;
17	"(D) orchards;
18	"(E) aquaculture facilities; and
19	"(F) forest land.
20	"(4) Silviculture operation.—
21	"(A) Definition of Silviculture oper-
22	ATION.—
23	"(i) In General.—In this paragraph,
24	the term 'silviculture operation' means the
25	practice of controlling the establishment,

1	composition, constitution, and growth of
2	forests.
3	"(ii) Inclusions.—The term
4	'silviculture operation' includes—
5	"(I) a nursery operation;
6	"(II) reforestation;
7	"(III) cultural treatment;
8	"(IV) thinning;
9	"(V) prescribed burning;
10	"(VI) a harvest operation;
11	"(VII) site preparation;
12	"(VIII) road construction and
13	maintenance;
14	"(IX) surface drainage; and
15	"(X) pest and fire control.
16	"(B) PERMIT REQUIREMENT.—The Ad-
17	ministrator shall not require a permit under
18	this section, nor shall the Administrator directly
19	or indirectly require any State to require such
20	a permit, for discharges from a silviculture op-
21	eration.".
22	(b) Conforming Amendment.—Section 502(14) of
23	the Federal Water Pollution Control Act (33 U.S.C.
24	1362(14)) is amended by striking the second sentence and
25	inserting the following: "The term does not include agri-

- 1 cultural stormwater discharges, return flows from irri-
- 2 gated agriculture, and discharges of stormwater runoff
- 3 from silviculture operations (as defined in section

4 402(1)(4)).".
