7	(2) by inserting after section 769, the following:
8	"SEC. 770. SOCIAL WORK TRAINING PROGRAM.
9	"(a) Training Generally.—The Secretary may
10	make grants to, or enter into contracts with, any public
11	or nonprofit private hospital, school offering programs in
12	social work, or to or with a public or private nonprofit
13	entity (which the Secretary has determined is capable of
14	carrying out such grant or contract)—
15	"(1) to plan, develop, and operate, or partici-
16	pate in, an approved social work training program
17	(including an approved residency or internship pro-
18	gram) for students, interns, residents, or practicing
19	physicians;
20	"(2) to provide financial assistance (in the form
21	of traineeships and fellowships) to students, interns,
22	residents, practicing physicians, or other individuals,
23	who are in need thereof, who are participants in any
24	such program, and who plan to specialize or work in
25	the practice of social work;
