To protect the permanent trust funds of the State of Arizona from erosion due to inflation and modify the basis on which distributions are made from those funds.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Arizona Statehood and
- 3 Enabling Act Amendments of 1999".
- 4 SEC. 2. PROTECTION OF TRUST FUNDS OF STATE OF ARI-
- 5 ZONA.
- 6 (a) IN GENERAL.—Section 28 of the Act of June 20,
- 7 1910 (36 Stat. 574, chapter 310) (as amended by section
- 8 2 of Public Law 85–180 (71 Stat. 457)) is amended in
- 9 the first paragraph by adding at the end the following:
- 10 "The trust funds (including all interest, dividends, other
- 11 income, and appreciation in the market value of assets of
- 12 the funds) shall be prudently invested on a total rate of
- 13 return basis. Distributions from the trust funds shall be
- 14 made as provided in Article 10, Section 7 of the Constitu-
- 15 tion of the State of Arizona.".
- 16 (b) Conforming Amendments.—
- 17 (1) Section 25 of the Act of June 20, 1910 (36)
- 18 Stat. 573, chapter 310), is amended in the proviso
- of the second paragraph by striking "the income
- therefrom only to be used" and inserting "distribu-

- 22 the first paragraph of section 28 and shall be used".
