## **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Alcoholic Beverage
- 5 Label Preservation Act of 1999".

1	SEC. 2. PROHIBITION ON ADDITIONAL STATEMENTS AND
2	REPRESENTATIONS.
3	(a) FINDING.—Section 202 of the Alcoholic Beverage
4	Labeling Act of 1988 (27 U.S.C. 213) is amended—
5	(1) in the first sentence, by striking "The" and
6	inserting "(a)(1) The";
7	(2) in the last sentence, by striking "It is there-
8	fore" and inserting the following:
9	"(b) It is"; and
10	(3) in subsection (a) (as designated in para-
11	graph (1)), by adding at the end the following:
12	"(2) Congress finds that—
13	"(A) the consumers would be confused by an
14	additional statement or representation, beyond the
15	statement required by this Act, on alcoholic beverage
16	containers relating to the health effects or con-
17	sequences of alcoholic beverage consumption;
18	"(B) any such additional statement or represen-
19	tation would conflict with, dilute, impede, and un-
20	dermine the clear reminder of the health effects or
21	consequences in the statement required by this Act;
22	"(C) the effects of and consequences arising
23	from drunk driving, underage drinking, drinking
24	during pregnancy, and alcoholism have had a dev-
25	astating effect on the health and safety of United
26	States citizens; and

1 "(D) prevention of the effects and consequences 2 is furthered by— 3 "(i) having an exclusive and clear state-4 ment on alcoholic beverage containers relating 5 to the health effects and consequences of alco-6 holic beverage consumption; and 7 "(ii) prohibiting any other statement or 8 representation pertaining to the health effects 9 or consequences of alcoholic beverage consump-10 tion.". 11 (b) PROHIBITION.—Section 205 of the Alcoholic Bev-12 erage Labeling Act of 1988 (27 U.S.C. 216) is amended— 13 (1) by striking "No" and inserting "(a) No"; 14 and 15 (2) by adding at the end the following: "(b) No container of an alcoholic beverage, or any 16 box, carton, or other package, irrespective of the material 17 18 from which made, that contains such a container, shall bear any statement or representation relating to alcoholic 19 beverages and health, other than the statement required 20
