To amend the Peace Corps Act to authorize appropriations for fiscal years 2000 through 2003 to carry out that Act, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. AUTHORIZATION OF APPROPRIATIONS FOR
- 4 FISCAL YEARS 2000 THROUGH 2003 TO CARRY
- 5 OUT THE PEACE CORPS ACT.
- 6 Section 3(b) of the Peace Corps Act (22 U.S.C.
- 7 2502(b)) is amended to read as follows:
- 8 "(b)(1) There are authorized to be appropriated to
- 9 carry out the purposes of this Act \$270,000,000 for fiscal
- 10 year 2000, \$298,000,000 for fiscal year 2001,

- 1 \$327,000,000 for fiscal year 2002, and \$365,000,000 for
- 2 fiscal year 2003.
- 3 "(2) Amounts authorized to be appropriated under
- 4 paragraph (1) for a fiscal year are authorized to remain
- 5 available for that fiscal year and the subsequent fiscal
- 6 year.".
