To improve the foreign language assistance program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Foreign Language
- 5 Education Improvement Amendments Act of 1999".
- 6 SEC. 2. FOREIGN LANGUAGE ASSISTANCE PROGRAM.
- 7 (a) Federal Share.—Section 7203 of the Foreign
- 8 Language Assistance Act of 1994 (20 U.S.C. 7513) is
- 9 amended—
- 10 (1) in subsection (a)(2), by striking "three
- 11 years" and inserting "not less than three and not
- more than five years";

1	(2) in subsection (b), by adding at the end the
2	following:
3	"(3) Heavily impacted schools.—The Sec-
4	retary shall use 50 percent of the funds appro-
5	priated to carry out this part for a fiscal year to
6	award grants for foreign language programs serving
7	students in elementary schools or secondary schools
8	described in section 1114(a)(1)(B), and notwith-
9	standing subsection (c) the Federal share of the cost
10	of such programs shall be 100 percent."; and
11	(3) in subsection (c)—
12	(A) by striking paragraph (2); and
13	(B) by redesignating paragraphs (3) and
14	(4) as paragraphs (2) and (3), respectively.
15	(b) Applications.—Section 7204(b) of the Foreign
16	Language Assistance Act of 1994 (20 U.S.C. 7514(b)) is
17	amended—
18	(1) by redesignating paragraphs (2) and (3) as
19	paragraphs (4) and (5);
20	(2) by inserting after paragraph (1) the follow-
21	ing:
22	"(2) make effective use of technology such as
23	computer assisted instruction, language laboratories,
24	or distance learning;

1	"(3) promote innovative activities such as im-
2	mersion, partial immersion, or content-based in-
3	struction;";
4	(3) in paragraph (4) (as redesignated by para-
5	graph (1)), by striking "or" after the semicolon;
6	(4) in paragraph (5) (as redesignated by para-
7	graph (1)), by striking the period and inserting ";
8	or''; and
9	(5) by adding at the end the following:
10	"(6) involve consortia with elementary schools
11	or secondary schools.".
12	(c) Incentive Payments.—Section 7205(a) of the
13	Foreign Language Assistance Act of 1994 (20 U.S.C.
14	7515(a)) is amended by striking "provides to students at-
15	tending such school" and inserting "initiates".
16	(d) Authorization of Appropriations.—Section
17	7206 of the Foreign Language Assistance Act of 1994 (20
18	U.S.C. 7516) is amended—
19	(1) by striking "\$35,000,000 for the fiscal year
20	1995" and inserting "\$50,000,000 for fiscal year
21	2000"; and
22	(2) by striking "\$20,000,000" and inserting
23	"\$25,000,000".
