Mr. MURKOWSKI (for himself and Mr. BINGAMAN) introduced the following bill; which was read twice and referred to the Committee on Banking, Housing, and Urban Affairs

A BILL

To include the District of Columbia, the Commonwealth of Puerto Rico, Guam, American Samoa, the United States Virgin Islands, and the Commonwealth of the Northern Mariana Islands in the 50 States Commemorative Coin Program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Commemorative Coin
5 Amendments Act of 1999”.

1 **SEC. 2. AMENDMENT TO COIN PROGRAM.**

2 Section 5112(*l*) of title 31, United States Code, is
3 amended by adding at the end the following:

4 “(8) INCLUSION OF NON-STATES.—

5 “(A) IN GENERAL.—During the 1-year pe-
6 riod beginning at the end of the period de-
7 scribed in paragraph (1)(A), quarter dollar
8 coins shall be minted and issued having designs
9 on the reverse side that are emblematic of each
10 of the 6 non-States.

11 “(B) APPLICABILITY.—The requirements
12 of paragraphs (2) through (6) shall apply to
13 coins issued in commemoration of the non-
14 States, except that, for purposes of this
15 paragraph—

16 “(i) references in those paragraphs to
17 ‘States’ and ‘the 50 States’ shall be con-
18 strued to be references to the 6 non-States;

19 “(ii) references in these paragraphs to
20 the ‘10-year period’ shall be construed to
21 be references to the 1-year period de-
22 scribed in subparagraph (A) of this para-
23 graph; and

24 “(iii) references in those paragraphs
25 to the ‘50 designs’ shall be construed to be

1 references to the 6 designs relating to the
 2 non-States.

3 “(C) ORDER.—Coins shall be minted and
 4 issued for non-States in the order in which they
 5 appear in subparagraph (D).

6 “(D) DEFINITION.—In this paragraph, the
 7 term ‘non-States’ means—

8 “(i) the District of Columbia;

9 “(ii) the Commonwealth of Puerto
 10 Rico;

11 “(iii) Guam;

12 “(iv) American Samoa;

13 “(v) the United States Virgin Islands;

14 and

15 “(vi) the Commonwealth of the North-
 16 ern Mariana Islands.”.
