## A BILL

- To make forestry insurance plans available to owners and operators of private forest land, to encourage the use of prescribed burning and fuel treatment methods on private forest land, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Forestry Initiative to
  - 5 Restore the Environment Act of 1999".
  - 6 SEC. 2. FORESTRY INSURANCE.
  - 7 (a) In General.—Section 508 of the Federal Crop
  - 8 Insurance Act (7 U.S.C. 1508) is amended in subsections

- 1 (l) and (m)(2) by inserting after "generally available from
- 2 private companies" each place it appears the following: "in
- 3 a State or area at rates and terms that are normal for
- 4 privately underwritten policies, as determined by the Cor-
- 5 poration".
- 6 (b) Pilot Program.—Section 508 of the Federal
- 7 Crop Insurance Act (7 U.S.C. 1508) is amended by adding
- 8 at the end the following:
- 9 "(o) Forestry Insurance Pilot Program.—The
- 10 Corporation shall conduct a pilot program in at least 4
- 11 States under which the Corporation shall offer forestry in-
- 12 surance plans to indemnify owners and operators of pri-
- 13 vate forest land that is used to produce a variety of types
- 14 of timber for loss of yield or prevented planting due to
- 15 drought, flood, or other natural disaster (as determined
- 16 by the Secretary), with an emphasis on small, nonindus-
- 17 trial owners and operators of private forest land.".
- 18 SEC. 3. FORESTRY INCENTIVES PROGRAM.
- 19 Section 4(a) of the Cooperative Forestry Assistance
- 20 Act of 1978 (16 U.S.C. 2103(a)) is amended in the second
- 21 sentence by inserting "increased seedling production ca-
- 22 pacity," after "prescribed burning,".

### 1 SEC. 4. RURAL FIRE PREVENTION AND CONTROL.

2	(a) In General.—Section 10(b) of the Cooperative
3	Forestry Assistance Act of 1978 (16 U.S.C. 2106(b)) is
4	amended—
5	(1) by striking paragraph (2) and inserting the
6	following:
7	"(2) provide financial, technical, and related as-
8	sistance to State foresters or equivalent State offi-
9	cials, and through them to other agencies and indi-
10	viduals, for the prescribed use of burning on private
11	forest land for the prevention, control, and suppres-
12	sion of fire, including providing grants to pay up to
13	75 percent of the cost of carrying out the burning";
14	(2) in paragraph (3), by striking "and" after
15	the semicolon;
16	(3) in paragraph (4), by striking the period at
17	the end and inserting "; and; and
18	(4) by adding at the end the following:
19	"(5) develop, in cooperation with the Adminis-
20	trator of the Environmental Protection Agency, edu-
21	cational and outreach programs and materials on
22	prescribed use of burning for the prevention, control,
23	and suppression of fire.".
24	(b) Authorization of Appropriations.—Section
25	10(e) of the Cooperative Forestry Assistance Act of 1978
26	(16 U.S.C. 2106(e)) is amended—

1	(1) in paragraph (1), by striking ", (2),";
2	(2) by redesignating paragraph (2) as para-
3	graph (3); and
4	(3) by inserting after paragraph (1) the fol-
5	lowing:
6	"(2) Prescribed burning.—There are au-
7	thorized to be appropriated to carry out subsection
8	(b)(2) $$10,000,000$ for each fiscal year.".
