Mr. Jeffords, from the Committee on Health, Education, Labor, and Pensions, reported the following original resolution; which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Committee on Health, Education, Labor, and Pensions.

- 1 Resolved, That, in carrying out its powers, duties, and
- 2 functions under the Standing Rules of the Senate, in ac-
- 3 cordance with its jurisdiction under rule XXV of such
- 4 rules, including holding hearings, reporting such hearings,
- 5 and making investigations as authorized by paragraphs 1
- 6 and 8 of rule XXVI of the Standing Rules of the Senate,
- 7 the Committee on Health, Education, Labor, and Pen-
- 8 sions is authorized from October 1, 1999, through Sep-
- 9 tember 30, 2000, and October 1, 2000, through February
- 10 28, 2001, in its discretion (1) to make expenditures from

- 1 the contingent fund of the Senate, (2) to employ per-
- 2 sonnel, and (3) with the prior consent of the Government
- 3 department or agency concerned and the Committee on
- 4 Rules and Administration, to use on a reimbursable or
- 5 non-reimbursable basis the services of personnel of any
- 6 such department or agency.
- 7 Sec. 2. The expenses of the committee for the period
- 8 October 1, 1999, through September 30, 2000, under this
- 9 resolution shall not exceed \$4,560,792, of which amount
- 10 (1) not to exceed \$22,500 may be expended for the pro-
- 11 curement of the services of individual consultants, or orga-
- 12 nizations thereof (as authorized by section 202(i) of the
- 13 Legislative Reorganization Act of 1946, as amended), and
- 14 (2) not to exceed \$15,000 may be expended for the train-
- 15 ing of the professional staff of such committee (under pro-
- 16 cedures specified by section 202(j) of the Legislative Reor-
- 17 ganization Act of 1946).
- 18 (b) For the period October 1, 2000, through Feb-
- 19 ruary 28, 2001, expenses of the committee under this res-
- 20 olution shall not exceed \$1,946,026, of which amount (1)
- 21 not to exceed \$22,500 may be expended for the procure-
- 22 ment of the services of individual consultants, or organiza-
- 23 tions thereof (as authorized by section 202(i) of the Legis-
- 24 lative Reorganization Act of 1946, as amended), and (2)
- 25 not to exceed \$15,000 may be expended for the training

- 1 of the professional staff of such committee (under proce-
- 2 dures specified by section 202(j) of the Legislative Reorga-
- 3 nization Act of 1946).
- 4 Sec. 3. The committee shall report its findings, to-
- 5 gether with such recommendations for legislation as it
- 6 deems advisable, to the Senate at the earliest practicable
- 7 date, but not later than February 29, 2000, and February
- 8 28, 2001, respectively.
- 9 Sec. 4. Expenses of the committee under this resolu-
- 10 tion shall be paid from the contingent fund of the Senate
- 11 upon vouchers approved by the chairman of the com-
- 12 mittee, except that vouchers shall not be required (1) for
- 13 the disbursement of salaries of employees paid at an an-
- 14 nual rate, or (2) for the payment of telecommunications
- 15 provided by the Office of the Sergeant at Arms and Door-
- 16 keeper, United States Senate, or (3) for the payment of
- 17 stationery supplies purchased through the Keeper of the
- 18 Stationery, United States Senate, or (4) for payments to
- 19 the Postmaster, United States Senate, or (5) for the pay-
- 20 ment of metered charges on copying equipment provided
- 21 by the Office of the Sergeant at Arms and Doorkeeper,
- 22 United States Senate, or (6) for the payment of Senate
- 23 Recording and Photographic Services, or (7) for payment
- 24 of franked and mass mail costs by the Sergeant at Arms
- 25 and Doorkeeper, United States Senate.

- 1 Sec. 5. There are authorized such sums as may be
- 2 necessary for agency contributions related to the com-
- 3 pensation of employees of the committee from October 1,
- 4 1999, through September 30, 2000, and October 1, 2000,
- 5 through February 28, 2001, to be paid from the Appro-
- 6 priations account for "Expenses of Inquiries and Inves-
