CONCURRENT RESOLUTION

Authorizing the use of the Capitol Grounds for the National Book Festival.

- 1 Resolved by the House of Representatives (the Senate
- 2 concurring),
- 3 SECTION 1. USE OF CAPITOL GROUNDS FOR NATIONAL
- 4 BOOK FESTIVAL.
- 5 The Library of Congress (in this resolution referred
- 6 to as the "sponsor"), in cooperation with the First Lady,
- 7 shall be permitted to sponsor a public event, the National
- 8 Book Festival (in this resolution referred to as the
- 9 "event"), on the Capitol Grounds on September 8, 2001,
- 10 or on such other date as the Speaker of the House of Rep-

- 1 resentatives and the Committee on Rules and Administra-
- 2 tion of the Senate may jointly designate.

3 SEC. 2. TERMS AND CONDITIONS.

- 4 (a) In General.—The event shall be free of admis-
- 5 sion charge to the public and arranged not to interfere
- 6 with the needs of Congress, under conditions to be pre-
- 7 scribed by the Architect of the Capitol and the Capitol
- 8 Police Board.
- 9 (b) Expenses and Liabilities.—The sponsor shall
- 10 assume full responsibility for all expenses and liabilities
- 11 incident to all activities associated with the event.

12 SEC. 3. EVENT PREPARATIONS.

- 13 (a) STRUCTURES AND EQUIPMENT.—Subject to the
- 14 approval of the Architect of the Capitol, the sponsor may
- 15 cause to be placed on the Capitol Grounds such stage,
- 16 seating, booths, sound amplification and video devices, and
- 17 other related structures and equipment as may be required
- 18 for the event, including equipment for the broadcast of
- 19 the event over radio, television, and other media outlets.
- 20 (b) Additional Arrangements.—The Architect of
- 21 the Capitol and the Capitol Police Board are authorized
- 22 to make any such additional arrangements as may be re-
- 23 quired to carry out the event.

1 SEC. 4. ENFORCEMENT OF RESTRICTIONS.

- 2 The Capitol Police Board shall provide for enforce-
- 3 ment of the restrictions contained in section 4 of the Act
- 4 of July 31, 1946 (40 U.S.C. 193d; 60 Stat. 718), con-
- 5 cerning sales, advertisements, displays, and solicitations
- 6 on the Capitol Grounds, as well as other restrictions appli-
- 7 cable to the Capitol Grounds, with respect to the event.
