- 3 SECTION 1. SHORT TITLE.
- 4 The Act may be cited as the "Straighter Talk on So-
- 5 cial Security Act of 2001".

1 SEC. 2. REDESIGNATION OF SOCIAL SECURITY TRUST

- 2 FUNDS.
- 3 The Federal Old-Age and Survivors Insurance Trust
- 4 Fund and the Federal Disability Insurance Trust Fund
- 5 are hereby redesignated as the "Federal Old-Age and Sur-
- 6 vivors Insurance Accounting Fund" and the "Federal Dis-
- 7 ability Insurance Accounting Fund", respectively.
- 8 SEC. 3. CONFORMING AMENDMENTS TO THE SOCIAL SECU-
- 9 RITY ACT.

- 24 and inserting "the Federal Old-Age and Survivors Ac-

3 SEC. 5. RULE OF CONSTRUCTION.

- 4 Whenever any reference is made in any provision of
- 5 law, regulation, rule, record, or document to the Federal
- 6 Old-Age and Survivors Insurance Trust Fund or the Fed-
- 7 eral Disability Insurance Trust Fund, such reference shall
- 8 be considered a reference to the Federal Old-Age and Sur-
- 9 vivors Accounting Fund or the Federal Disability Insur-
- 10 ance Accounting Fund, respectively.
