A BILL

To provide for increased accountability with respect to the education and training of foreign military personnel, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Foreign Military
- 5 Training Responsibility Act".
- 6 SEC. 2. FINDING; SENSE OF CONGRESS.
- 7 (a) FINDING.—Congress finds that the United States
- 8 provides education and training for approximately 38,000

- 1 foreign military personnel, other than military personnel
- 2 of North Atlantic Treaty Organization (NATO) countries,
- 3 every year.
- 4 (b) Sense of Congress.—It is the sense of Con-
- 5 gress that—
- 6 (1) the United States shares a responsibility for
- 7 actions of those foreign military personnel for which
- 8 it provides education and training; and
- 9 (2) therefore the United States should take a
- serious approach to evaluating the objectives, meth-
- ods, and results of such education and training, in-
- 12 cluding evaluating and tracking the personnel for
- which it provides such education and training.
- 14 SEC. 3. ANNUAL FOREIGN MILITARY TRAINING REPORT.
- 15 (a) Contents.—Section 656(b) of the Foreign As-
- 16 sistance Act of 1961 (22 U.S.C. 2416(b)) is amended by
- 17 adding at the end the following:
- 18 "(4) United States Government personnel
- 19 (other than United States military units referred to
- in paragraph (3)) and non-United States Govern-
- 21 ment personnel, including private contractors, in-
- volved in each military training activity.".
- 23 (b) FORM.—Section 656(c) of the Foreign Assistance
- 24 Act of 1961 (22 U.S.C. 2416(c)) is amended—

- 1 (1) by striking "The report" and inserting the 2 following:
- 3 "(1) IN GENERAL.—Subject to paragraph (2), 4 the report"; and
- 5 (2) by adding at the end the following:
- 6 ADDITIONAL REQUIREMENT.—Notwith-7 standing paragraph (1), all information relating to 8 the number of foreign military personnel provided 9 training for each military training activity, their 10 units of operation, and the location of the training, 11 pursuant to subsection (b)(1) and all information 12 pursuant to subsection (b)(2) shall be in unclassified form.". 13

14 SEC. 4. ANNUAL FOREIGN POLICE TRAINING REPORT.

- 15 Section 660 of the Foreign Assistance Act of 1961
- 16 (22 U.S.C. 2420) is amended by adding at the end the
- 17 following:
- 18 "(e)(1) Not later than January 31 of each year, the
- 19 Secretary of State, in conjunction with the head of each
- 20 other appropriate department or agency, shall prepare and
- 21 submit to the appropriate congressional committees a re-
- 22 port on all police training, advice, or financial support de-
- 23 scribed in subsection (a) provided during the previous fis-
- 24 cal year and all such training, advice, or support proposed
- 25 for the current fiscal year.

- 1 "(2) The report described in paragraph (1) shall in-2 clude the following:
- 3 "(A) For each activity, the foreign policy jus-4 tification and purpose for the activity, and with re-
- 5 spect to police training, the number of personnel
- 6 provided training and their units of operation, and
- 7 the location of the training.
- 8 "(B) For each country, the aggregate number 9 of personnel trained and the aggregate cost of the
- police training activities.
- "(C) With respect to United States Government personnel, the operational benefits to the United States derived from each police training activity and the United States Government personnel involved in
- each activity.
- "(D) Non-United States Government personnelinvolved in each police training activity.
- 18 "(3)(A) Subject to subparagraph (B), the report de-
- 19 scribed in paragraph (1) shall be in unclassified form but
- 20 may include a classified annex.
- 21 "(B) Notwithstanding subparagraph (A), all informa-
- 22 tion relating to the number of personnel provided training
- 23 for each activity pursuant to paragraph (2)(A) and all in-
- 24 formation pursuant to paragraph (2)(B) shall be in un-
- 25 classified form.

- 1 "(4) All unclassified portions of the report described
- 2 in paragraph (1) shall be made available to the public on
- 3 the Internet through the Department of State.
- 4 "(5) In this subsection, the term 'appropriate con-
- 5 gressional committees' means—
- 6 "(A) the Committee on Appropriations and the
- 7 Committee on International Relations of the House
- 8 of Representatives; and
- 9 "(B) the Committee on Appropriations and the
- 10 Committee on Foreign Relations of the Senate.".
- 11 SEC. 5. RECORDS RELATING TO FOREIGN MILITARY AND
- 12 **POLICE TRAINING.**
- 13 (a) Records.—Chapter 3 of part II of the Foreign
- 14 Assistance Act of 1961 (22 U.S.C. 2401 et seq.) is amend-
- 15 ed by inserting after section 660 the following:
- 16 "SEC. 660A. RECORDS RELATING TO FOREIGN MILITARY
- 17 AND POLICE TRAINING.
- 18 "(a) Records.—The Secretary of Defense, the Sec-
- 19 retary of State, and the head of each other appropriate
- 20 department or agency shall jointly develop and maintain
- 21 a database containing records on each foreign military
- 22 participant and each foreign law enforcement participant
- 23 in education and training activities conducted by the
- 24 United States Government pursuant to any other provi-
- 25 sion of law after December 31, 2001.

- 1 "(b) CONTENTS.—Each record shall include the type
- 2 of instruction received, the dates of the instruction, wheth-
- 3 er such instruction was completed successfully, and, to the
- 4 extent practicable, a record of the participant's subsequent
- 5 military or law enforcement career, including the partici-
- 6 pant's current position and location.".
- 7 SEC. 6. TASK FORCE ON EDUCATION AND TRAINING FOR
- 8 MILITARY PERSONNEL OF FOREIGN COUN-
- 9 TRIES.
- 10 (a) Establishment.—There is established a task
- 11 force to conduct an assessment of the kind of education
- 12 and training that is appropriate for the Department of
- 13 Defense to provide to military personnel of foreign coun-
- 14 tries.
- 15 (b) Composition.—The task force shall be composed
- 16 of eight Members of Congress, of whom two each shall
- 17 be designated by the Speaker of the House of Representa-
- 18 tives, the minority leader of the House of Representatives,
- 19 the majority leader of the Senate, and the minority leader
- 20 of the Senate.
- 21 (c) Report.—Not later than one year after the date
- 22 of the enactment of this Act, the task force shall submit
- 23 to Congress a report on its assessment as specified in sub-
- 24 section (a). The report shall include—

[(1) a critical assessment of courses, curriculum,
2	and procedures appropriate for such education and
3	training;

- (2) an evaluation of the effect of such education and training on the performance of military personnel of foreign countries in the areas of human rights and adherence to democratic principles and the rule of law;
- (3) an evaluation of compliance by the United States Government with requirements that prohibit the training of military personnel of foreign countries involved in human rights violations;
- (4) an evaluation of such education and training for military personnel of countries with limited civilian control of the military; and
- (5) a description of criteria for limiting such education and training for military personnel of countries with limited civilian control of the military.
- 19 (d) DEFINITION.—In this subsection, the term 20 "Member" includes a Delegate to, or Resident Commis-21 sioner, in the Congress.
