## A BILL

To provide grants to States to establish, expand, or enhance prekindergarten programs for children who are not yet enrolled in kindergarten.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. PREKINDERGARTEN PROGRAM.**

4       Title X of the Elementary and Secondary Education  
5       Act of 1965 is amended by adding at the end the fol-  
6       lowing:

7       **“PART M—PREKINDERGARTEN PROGRAMS**

8       **“SEC. 10996A. FINDINGS.**

9       “Congress finds the following:

1           “(1) Countless studies have shown what every  
2           parent already knows: High-quality preschool edu-  
3           cation programs work. They prepare children to  
4           learn when they go to school, and the programs in-  
5           crease the success of students throughout their lives.

6           “(2) Children who get a high-quality prekinderg-  
7           garten education are less likely to repeat a grade  
8           level and have less need for special education in-  
9           struction than those with no prekindergarten experi-  
10          ence.

11          “(3) Prekindergarten programs make a signifi-  
12          cant difference in the lives of children from low-in-  
13          come families. A recent study found that children in  
14          high-quality child care programs had better thinking  
15          and attention skills, better mathematics and pre-  
16          reading skills, and fewer behavioral problems.

17          “(4) In a study following children to age 21  
18          who received high-quality early children education,  
19          such children were more likely to have enrolled in  
20          college, been employed, and delayed parenthood.

21       **“SEC. 10996B. DEFINITIONS.**

22          “For purposes of this part, the following definitions  
23       shall apply:

24          “(1) PREKINDERGARTEN.—The term ‘pre-  
25       kindergarten’ means a program serving children

1       ages 3, 4, and 5 years old that supports children’s  
2       cognitive, social, emotional, and physical develop-  
3       ment and helps prepare children for the transition to  
4       kindergarten.

5               “(2) ELIGIBLE PREKINDERGARTEN PRO-  
6       VIDERS.—The term ‘eligible prekindergarten pro-  
7       viders’ includes child care programs, Head Start  
8       agencies, and schools that—

9               “(A) have met applicable State licensing  
10       requirements and have obtained accreditation  
11       by a national accrediting body with dem-  
12       onstrated experience in accrediting child care,  
13       prekindergarten programs, or schools; or

14              “(B) agree to obtain such accreditation not  
15       later than 3 years after receipt of a grant under  
16       this part.

17       “(c) PREKINDERGARTEN TEACHER.—The term ‘pre-  
18       kindergarten teacher’ means an individual who has or is  
19       working toward a bachelor of arts degree in early child-  
20       hood development.

21       **“SEC. 10996C. PROGRAM AUTHORIZED.**

22       “(a) IN GENERAL.—The Secretary is authorized to  
23       provide grants to a State with an approved application  
24       under section 10996D to allow such State to establish or  
25       expand prekindergarten early learning programs by eligi-

1 ble prekindergarten providers and local educational agen-  
2 cies in partnership with early childhood programs, organi-  
3 zations, or agencies that serve prekindergarten school chil-  
4 dren.

5 “(b) STATE APPLICATION.—

6 “(1) IN GENERAL.—The State shall designate a  
7 State agency to administer, including the receipt and  
8 administration of funds and the evaluation of the  
9 program, the State-funded prekindergarten program  
10 funded under this part.

11 “(2) STATE APPLICATION.—The appropriate  
12 agency shall submit an application to the Secretary  
13 that includes—

14 “(A) an assurance that the State will pro-  
15 vide non-Federal matching funds equal to not  
16 less than 20 percent of the award; and

17 “(B) a description of—

18 “(i) how grant funds will be used to  
19 expand or enhance existing efforts across  
20 the State in providing access to high qual-  
21 ity prekindergarten programs;

22 “(ii) how the State will collaborate  
23 with local child care agencies and councils,  
24 including local child care resource and re-  
25 ferral agencies;

1 “(iii) how grant funds will be used to  
2 supplement and not supplant existing Fed-  
3 eral, State, local and private funds used  
4 for prekindergarten programs;

5 “(iv) how the State will ensure that  
6 grant funds are provided to a range of  
7 types of eligible prekindergarten providers;

8 “(v) how the State will help eligible  
9 prekindergarten providers attract and re-  
10 tain qualified prekindergarten teachers;

11 “(vi) how the State will identify the  
12 eligible children and eligible prekind-  
13 garten providers; and

14 “(vii) how the State will give priority  
15 to full-time prekindergarten programs, in-  
16 cluding the expansion of existing part-time  
17 programs into full-time programs.

18 **“SEC. 10996D. LOCAL APPLICATIONS.**

19 “(a) IN GENERAL.—A local educational agency or eli-  
20 gible prekindergarten provider, as the case may be, that  
21 desires to receive a grant under this part shall submit an  
22 application to the State agency designated under section  
23 10996C(b) at such time, in such manner, and containing  
24 such information as such agency may reasonably require.

1       “(b) SPECIAL RULE.—If the State prekindergarten  
2 program is not operated through the local educational  
3 agency, then the State shall award subgrants to eligible  
4 prekindergarten providers that currently administer pre-  
5 kindergarten programs at the local level.

6       “(c) CONTENT.—An application referred to in sub-  
7 section (a), at a minimum, shall—

8               “(1) demonstrate a need for the establishment,  
9 enhancement, or expansion of a prekindergarten pro-  
10 gram;

11              “(2) describe how the local educational agency  
12 or eligible prekindergarten provider collaborates with  
13 local early childhood councils and agencies;

14              “(3) provide an assurance that each individual  
15 hired is qualified to teach children at the prekinde-  
16 rgarten level;

17              “(4) provide an assurance that the ratio of  
18 teacher or child development specialist to children  
19 shall not exceed 1–10;

20              “(5) provide a description of how funds will be  
21 used to coordinate with and enhance, but not dupli-  
22 cate or supplant, early childhood programs serving  
23 eligible children that exist in the community;

24              “(6) describe how the agency or eligible pre-  
25 kindergarten provider will use a collaborative process

1 with organizations and members of the community  
2 that have an interest and experience in early child-  
3 hood development and education to establish, ex-  
4 pand, or enhance prekindergarten programs;

5 “(7) describe how the program will meet the di-  
6 verse needs of children, ages 3 through 5, in the  
7 community who are not enrolled in kindergarten, in-  
8 cluding children with disabilities or whose native lan-  
9 guage is other than English;

10 “(8) describe how the agency or eligible pre-  
11 kindergarten provider will collaborate with local  
12 schools to ensure a smooth transition for partici-  
13 pating students from early childhood education to  
14 kindergarten and early elementary education;

15 “(9) describe the results the programs are in-  
16 tended to achieve, and what tools will be used to  
17 measure the progress in attaining those results; and

18 “(10) provide an assurance that none of the  
19 funds received under this part may be used for the  
20 construction or renovation of existing or new facili-  
21 ties (except for minor remodeling needed to accom-  
22 plish the purposes of this part).

23 **“SEC. 10996E. USES OF FUNDS.**

24 “(a) IN GENERAL.—An agency or eligible prekind-  
25 garten provider that receives a grant award under this

1 part shall use funds received to establish, enhance, or ex-  
2 pand prekindergarten programs for children, ages 3  
3 through 5, who are not enrolled in kindergarten,  
4 including—

5           “(1) providing a program that focuses on the  
6 developmental needs of participating children, in-  
7 cluding their social, cognitive, physical, and lan-  
8 guage-development needs, and using research-based  
9 approaches that build on competencies that lead to  
10 school success, particularly in language and literacy  
11 development and in reading;

12           “(2) paying the costs of purchasing educational  
13 equipment, including educational materials, nec-  
14 essary to provide a high quality program;

15           “(3) pursuing accreditation by a national ac-  
16 creditation body with demonstrated experience in ac-  
17 creditation of prekindergarten programs, to be ob-  
18 tained not later than 3 years after the date of re-  
19 ceipt of funds under this part;

20           “(4) helping prekindergarten teachers pursue  
21 and attain the credential and degree requirements  
22 established by the State and provide a stipend for  
23 attaining educational or professional development;  
24 and

25           “(5) meeting the needs of working parents.



1       “(b) PERMISSIBLE USES OF FUNDS.—A prekin-  
 2   garten program established under this part may use funds  
 3   received under this part to pay for transporting students  
 4   to and from a prekindergarten program.

5   **“SEC. 10996F. REPORTING.**

6       “(a) LOCAL REPORTS.—Each local educational agen-  
 7   cy or eligible prekindergarten provider that receives a  
 8   grant award under this part shall submit an annual report  
 9   to the designated State agency that reviews the effective-  
 10   ness of the prekindergarten program established with  
 11   funds provided under this part on—

12           “(1) number and ages of children served, in-  
 13       cluding information (disaggregated by family in-  
 14       come, race, disability, native language);

15           “(2) number of hours of service per day and  
 16       number of months;

17           “(3) number of prekindergarten teachers; and

18           “(4) other sources of Federal, State, local, and  
 19       private funds used to operate a program.

20       “(b) REPORT TO CONGRESS.—The Secretary shall  
 21   submit an annual report to Congress that evaluates the  
 22   prekindergarten programs established under this part.

23   **“SEC. 10996G. AUTHORIZATION OF APPROPRIATIONS.**

24       “There are authorized to be appropriated to carry out  
 25   this part \$2,000,000,000 for fiscal year 2001,

- 1 \$4,000,000,000 for fiscal year 2002, \$5,000,000,000 for
- 2 fiscal year 2003, \$8,000,000,000 for fiscal year 2004, and
- 3 \$10,000,000,000 for fiscal year 2005.”.
