## A BILL

To provide for the conveyance of certain National Forest System lands to the towns of Laona and Wabeno, Wisconsin.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. LAND CONVEYANCES, NICOLET NATIONAL FOR-**  
4       **EST, WISCONSIN.**

5       (a) CONVEYANCE TO TOWN OF LAONA.—

6               (1) CONVEYANCE.—The Secretary of Agri-  
7       culture (referred to in this section as the “Sec-  
8       retary”) shall convey, without consideration, to the  
9       town of Laona, Wisconsin, all right, title, and inter-  
10      est of the United States in and to the parcel of Na-

1 tional Forest System land in Forest County, Wis-  
2 consin, described in paragraph (2), for the purpose  
3 of permitting the town to use the parcel as a site for  
4 an industrial park and for other purposes.

5 (2) LEGAL DESCRIPTION.—The parcel of land  
6 referred to in paragraph (1) consists of the SW.  $\frac{1}{4}$   
7 of the NW.  $\frac{1}{4}$ , SE.  $\frac{1}{4}$  of the NW.  $\frac{1}{4}$ , NE.  $\frac{1}{4}$  of  
8 the SW.  $\frac{1}{4}$ , NW  $\frac{1}{4}$  of the SW.  $\frac{1}{4}$ , and that part  
9 of the SW.  $\frac{1}{4}$  of the NE.  $\frac{1}{4}$  not previously conveyed  
10 by the United States in section 6, townships 35 and  
11 36 north, range 15 east, Forest County, Wisconsin.

12 (b) CONVEYANCE TO TOWN OF WABENO.—

13 (1) CONVEYANCE.—The Secretary shall convey,  
14 without consideration, to the town of Wabeno, Wis-  
15 consin, all right, title, and interest of the United  
16 States in and to the parcel of National Forest Sys-  
17 tem land in Forest County, Wisconsin, described in  
18 paragraph (2), for the purpose of permitting the  
19 town to use the parcel as a site for an industrial  
20 park and for other purposes.

21 (2) LEGAL DESCRIPTION.—The parcel of land  
22 referred to in paragraph (1) consists of the SE.  $\frac{1}{4}$   
23 of the SW.  $\frac{1}{4}$ , part of the NW.  $\frac{1}{4}$  of the SW.  $\frac{1}{4}$ ,  
24 NE.  $\frac{1}{4}$  of the SW.  $\frac{1}{4}$ , SW  $\frac{1}{4}$  of the NW.  $\frac{1}{4}$ , and

1 SE.  $\frac{1}{4}$  of the NW.  $\frac{1}{4}$  in section 7, township 34  
2 north, range 15 east, Forest County, Wisconsin.

3 (c) SURVEY.—If necessary, the exact acreage and  
4 legal description of the lands to be conveyed under sub-  
5 sections (a) and (b) shall be determined by surveys satis-  
6 factory to the Secretary. The cost of a survey shall be  
7 borne by the recipient of the land.

8 (d) ADDITIONAL TERMS AND CONDITIONS.—The  
9 Secretary may require such additional terms and condi-  
10 tions in connection with the conveyances under this section  
11 as the Secretary considers appropriate to protect the inter-  
12 ests of the United States.
