A BILL

To authorize the Secretary of the Interior to construct a

bridge on Federal land west of and adjacent to Folsom Dam in California, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*
3 **SECTION 1. CONSTRUCTION OF BRIDGE ADJACENT TO FOL-
4 SOM DAM, CALIFORNIA.**

5 *(a) IN GENERAL.—The Secretary of the Interior may
6 carry out a project to design and construct a bridge on Fed-
7 eral land west of and adjacent to Folsom Dam in Cali-
8 fornia. In carrying out the project, the Secretary may also
9 construct necessary linkages from the bridge to existing
10 roadways and provide for reestablishment of administrative
11 facilities located at the Dam that will be affected by con-
12 struction of the bridge.*

13 *(b) DESIGN AND CONSTRUCTION.—In designing and
14 constructing the bridge, the Secretary shall—*

15 *(1) maximize the economy, safety, and security
16 of Folsom Dam’s future operation, maintenance, and
17 construction activities; and*

18 *(2) provide appropriate sizing and linkages to
19 support present and future traffic flow requirements
20 for the city of Folsom.*

21 *(c) TRANSFER TO CITY OF FOLSOM.—Before initiation
22 of construction of the bridge, the Secretary shall enter into
23 an agreement with the city of Folsom to provide that, upon
24 completion of construction of the bridge—*

1 *(1) the Secretary shall transfer to the city of Folsom all right, title, and interest of the United States*
2 *to the bridge and connecting structures;*

4 *(2) the Secretary shall transfer to the city of Folsom necessary easements to provide access to the*
5 *bridge; and*

7 *(3) the city of Folsom shall assume full responsibility for operation and maintenance of the bridge*
8 *and connecting structures in perpetuity.*

10 *(d) AUTHORIZATION OF APPROPRIATIONS.—There is*
11 *authorized to be appropriated to carry out this section a*
12 *total of \$66,500,000 for fiscal years beginning after Sep-*
13 *tember 30, 2001.*
