Mr. Young of Alaska introduced the following bill; which was referred to the Committee on Government Reform

A BILL

To amend title 39, United States Code, to direct the Postal Service to adhere to an equitable tender policy in selecting air carriers of non-priority bypass mail to certain points in the State of Alaska, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SELECTION OF CARRIERS OF NON-PRIORITY
- 4 BYPASS MAIL TO CERTAIN POINTS IN
- 5 ALASKA.
- 6 (a) REQUIREMENTS FOR SELECTION.—Section
- 7 5402(g)(1) of title 39, United States Code, is amended—

1	(1) in the matter preceding subparagraph (A)
2	by inserting after "in the State of Alaska," the fol-
3	lowing: "shall adhere to an equitable tender policy
4	among the carriers and"; and
5	(2) by striking subparagraph (B) and inserting
6	the following:
7	"(B) operate at least 1, 2, or 3 (as determined
8	by the Postal Service based on its needs) scheduled
9	flights each week to such point;".
10	(b) Determination of Rates.—Section 5402(g)(2)
11	of such title is amended—
12	(1) by striking "and" at the end of subpara-
13	graph (A);
14	(2) by striking the period at the end of sub-
15	paragraph (B) and inserting "; and; and
16	(3) by adding at the end the following:
17	"(C) may offer equitable tender of non-priority
18	bypass mail at mainline service rates to a bush car-
19	rier providing service within the State of Alaska
20	from a hub point to a bush point if the bush point
21	is also being served by a mainline carrier.".
22	(c) Selection of Carriers to Hub Points.—Sec-
23	tion 5402(g) of such title is amended by adding at the
24	end the following:

- 1 "(4)(A) Except as provided in subparagraph (B), the
- 2 Postal Service shall select only existing mainline carriers
- 3 to provide non-priority bypass mail service to hub points
- 4 in the State of Alaska.
- 5 "(B) The Postal Service may select a carrier other
- 6 than an existing mainline carrier to provide non-priority
- 7 bypass mail service to a hub point in the State of Alaska
- 8 if—
- 9 "(i) the Postal Service determines (in accord-
- ance with criteria established in advance by the
- 11 Postal Service) that service to the hub point is defi-
- cient and provides written notice of the determina-
- tion to existing mainline carriers to the hub point;
- 14 and
- 15 "(ii) after the 30-day period following issuance
- of notice under clause (i), the Postal Service deter-
- mines that deficiencies in service to the hub point
- have not been cured.".
- 19 (d) Definitions.—Section 5402(g) of such title is
- 20 further amended by adding at the end the following:
- 21 "(5) In this subsection—
- 22 "(A) the term 'equitable tender' means the
- practice of the Postal Service of equitably distrib-
- 24 uting mail on a fair and reasonable basis between
- 25 those air carriers that offer equivalent services be-

1	tween 2 communities in terms of the requirements
2	of the Postal Service;
3	"(B) the term 'existing mainline carrier' means
4	a mainline carrier that meets the requirements of
5	paragraph (1) and was actually providing mainline
6	non-priority bypass mail service within the State of
7	Alaska as of January 1, 2001; and
8	"(C) the term 'scheduled service' means service
9	published in the Official Airline Guide or the air
10	cargo equivalent thereof.".
