A BILL

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PARITY OF TREATMENT.
- 4 (a) In General.—The Office of Personnel Manage-
- 5 ment shall by regulation provide, with respect to benefits

1	payable out of the Civil Service Retirement and Disability
2	Fund, for such rules as may be necessary to provide for—
3	(1) the same treatment with respect to individ-
4	uals who (disregarding this Act) would be entitled,
5	based on the service of the same person, to both—
6	(A) any benefits so payable, and
7	(B) veterans' disability compensation, as
8	(2) is then currently by law provided (including
9	under sections 5304–5305 of title 38, United States
10	Code) with respect to individuals who (disregarding
11	such sections) would be entitled, based on the service
12	of the same person, to both—
13	(A) retirement pay, and
14	(B) veterans' disability compensation,
15	in connection with that simultaneous entitlement.
16	(b) Definitions.—For purposes of this Act—
17	(1) the term "veterans' disability compensa-
18	tion" has the meaning given the term "compensa-
19	tion" in section 101 of title 38, United States Code;
20	and
21	(2) the term "retirement pay" means any re-
22	tirement pay, pension, or other benefit subject to
23	sections 5304–5305 of title 38, United States Code
24	(as in effect on the date of enactment of this Act).

SEC. 2. APPLICABILITY TO OTHER GOVERNMENT RETIRE-2 MENT SYSTEMS. 3 In order to maintain existing conformity among Government retirement systems, regulations comparable to 4 5 those required under section 1 shall be prescribed— 6 (1) under section 827 of the Foreign Service 7 Act of 1980 (22 U.S.C. 4067) for purposes of the 8 Foreign Service Retirement and Disability System and the Foreign Service Pension System; and 9 10 (2) under section 292 of the Central Intel-11 ligence Agency Retirement Act (50 U.S.C. 2141) for 12 purposes of the Central Intelligence Agency Retire-13 ment and Disability System. 14 SEC. 3. EFFECTIVE DATE. 15 This Act shall apply in the case of any individual who 16 (disregarding this Act) becomes entitled, on or after the date of enactment of this Act— 17 18 (1) to both retirement benefits and veterans' 19 disability compensation (within the meaning of, and 20 in the circumstance described in, section 1(a)(1); or 21 (2) if a retirement system under section 2 is in-22 volved, to both veterans' disability compensation and 23 retirement benefits under such system corresponding 24 to the retirement benefits referred to in paragraph

(1).
