## A BILL

To amend title 49, United States Code, to require that the screening of passengers and property on flights in air transportation be carried out by employees of the Federal Aviation Administration, to expand the Federal Air Marshal program of the Federal Aviation Administration, to establish requirements for carry-on baggage on flights in air transportation, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### SECTION 1. SHORT TITLE.

- This Act may be cited as the "Aviation Security En-
- 3 hancement Act of 2001".
- 4 SEC. 2. SCREENING OF AIR PASSENGERS AND PROPERTY
- 5 BY FAA.
- 6 Section 44901 of title 49, United States Code, is
- 7 amended—
- 8 (1) in the second sentence of subsection (a) by
- 9 striking "The" and inserting "Subject to subsection
- 10 (c), the"; and
- 11 (2) by adding at the end the following:
- 12 "(d) Screening To Be Conducted by FAA Em-
- 13 PLOYEES.—As soon as practicable after the date of enact-
- 14 ment of this subsection, the screening of passengers and
- 15 property under subsection (a) shall be carried out by em-
- 16 ployees of the Federal Aviation Administration. The Ad-
- 17 ministrator may prioritize the undertaking of screening re-
- 18 sponsibilities with respect to an airport based on the Ad-
- 19 ministrator's assessment of the security threat to the air-
- 20 port.".
- 21 SEC. 3. EXPANSION OF FEDERAL AIR MARSHAL.
- The Administrator of the Federal Aviation Adminis-
- 23 tration shall expand the Federal Air Marshal program of
- 24 the Administration to increase the number of air marshals
- 25 on domestic and international flights of United States air
- 26 carriers.

| 14 | TION.—In this section, the term "carry-on baggage" does        |
| 15 | not include any of the following items:                        |
| 16 | (1) Child safety seats for children holding a                  |
| 17 | ticket for a flight segment.                                   |
| 18 | (2) Baggage and equipment required for the                     |
| 19 | transportation of any child under the age of 2, as             |
| 20 | determined by the Administrator.                               |
| 21 | (3) Assistive devices for disabled passengers, in-             |
| 22 | cluding canes and crutches.                                    |

- 23 (4) Outer garments, including coats and hats.
- 24 (5) Purses that are no larger than 25 linear 25 inches.

- 1 (c) Passenger Defined.—In this section, the term
- 2 "passenger" includes any child under the age of 2 who
- 3 boards an airplane of a certificate holder, without regard
- 4 to whether a ticket for air transportation was purchased
- 5 for the child.

### 6 SEC. 5. FUNDING.

- 7 The Administrator of the Federal Aviation Adminis-
- 8 tration may impose a fee under section 45301 of title 49,
- 9 United States Code, of not more than \$3.00 per domestic
- 10 flight segment, the receipts from which shall be available
- 11 immediately for obligation and expenditure to carry out
- 12 sections 2 and 3 of this Act (including the amendments
- 13 made by such sections).
