A BILL

To increase the assistance made available under certain economic development programs.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Job Creation and Eco-
- 5 nomic Revitalization Act of 2001".

1 SEC. 2. COMMUNITY DEVELOPMENT FINANCIAL INSTITU-

- 2 TIONS.
- 3 Paragraph (1) of section 121(a) of the Community
- 4 Development Banking and Financial Institutions Act of
- 5 1994 (12 U.S.C. 4718(a)(1)) is amended to read as fol-
- 6 lows:
- 7 "(1) IN GENERAL.—To carry out this subtitle,
- 8 there are authorized to be appropriated to the Fund,
- 9 to remain available until expended, \$2,000,000,000
- for fiscal year 2002, or such greater sums as may
- be necessary to carry out this subtitle.".
- 12 SEC. 3. NEW MARKETS INITIATIVE.
- 13 Section 368(a)(1) of the Small Business Investment
- 14 Act of 1958 (15 U.S.C. 689q(a)(1)) is amended by strik-
- 15 ing "\$150,000,000" and inserting "\$2,000,000,000".
- 16 SEC. 4. COMMUNITY DEVELOPMENT LOAN GUARANTEES.
- 17 Section 108(a) of the Housing and Community De-
- 18 velopment Act of 1974 (42 U.S.C. 5308(a)) is amended
- 19 adding at the end the following: "There is authorized to
- 20 be appropriated for the cost (as such term is defined in
- 21 section 502 of the Congressional Budget Act of 1974) of
- 22 notes and obligations guaranteed under this section,
- 23 \$1,000,000,000, for fiscal year 2002. Notwithstanding
- 24 any other provision of law and subject only to the absence
- 25 of qualified applicants or proposed activities and to the
- 26 authority provided in this section, the Secretary shall

- 1 enter into commitments to guarantee notes and obliga-
- 2 tions under this section to the extent that amounts appro-
- 3 priated to cover the costs of such notes and obligations
- 4 are provided in advance in appropriation Acts.".

5 SEC. 5. EMPOWERMENT ZONES AND ENTERPRISE COMMU-

6 NITIES.

- 7 There is authorized to be appropriated for grants in
- 8 connection with the second round of empowerment zones
- 9 and enterprise communities designated pursuant to sec-
- 10 tion 1391(g) of the Internal Revenue Code of 1986 (26
- 11 U.S.C. 1391(g)), \$2,000,000 for fiscal year 2002. Subject
- 12 only to the availability of sufficient funds made available
- 13 for such purpose, \$10,000,000 of any amounts appro-
- 14 priated for such grants shall be available for each such
- 15 empowerment zone for use in conjunction with economic
- 16 development activities consistent with the strategic plan
- 17 of each such zone.

18 SEC. 6. ECONOMIC DEVELOPMENT CORPORATIONS.

- 19 Section 701 of the Public Works and Economic De-
- 20 velopment Act of 1965 (42 U.S.C. 3231) is amended by
- 21 striking "\$335,000,000" the second place it appears and
- 22 inserting "\$2,000,000,000".
