A BILL

- To require the display of the POW/MIA flag at the World War II memorial, the Korean War Veterans Memorial, and the Vietnam Veterans Memorial in the District of Columbia.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "POW/MIA Memorial
 - 5 Flag Act of 2001".

1	SEC. 2. DISPLAY OF POW/MIA FLAG AT WORLD WAR II ME-
2	MORIAL, KOREAN WAR MEMORIAL, AND VIET-
3	NAM VETERANS MEMORIAL IN THE DISTRICT
4	OF COLUMBIA.
5	(a) Requirement for Display.—Subsection (d)(3)
6	of section 902 of title 36, United States Code, is amended
7	to read as follows:
8	"(3) The World War II memorial, the Korean
9	War Veterans Memorial, and the Vietnam Veterans
10	Memorial in the District of Columbia.".
11	(b) Days for Display.—Subsection (c)(2) of that
12	section is amended—
13	(1) by redesignating subparagraphs (A) and
14	(B) as subparagraphs (B) and (C), respectively; and
15	(2) by inserting before subparagraph (B), as so
16	redesignated, the following new subparagraph (A):
17	"(A) in the case of display at the World
18	War II memorial, Korean War Veterans Memo-
19	rial, and Vietnam Veterans Memorial (required
20	by subsection (d)(3) of this section), any day on
21	which the flag of the United States is dis-
22	played;".
23	(c) DISPLAY ON EXISTING FLAGPOLE.—The amend-
24	ments made by this section may not be construed to re-
25	quire the acquisition or erection of a new or additional
26	flagpole for purposes of the display of the POW/MIA flag.

- 1 (d) Application of Requirements to World
- 2 War II Memorial.—Section 902 of title 36, United
- 3 States Code, as amended by this section, shall apply with
- 4 respect to the World War II memorial in the District of
- 5 Columbia only after construction of the memorial is com-
- 6 pleted and the memorial is opened for visitation by the

7 general public.
