## A BILL

To extend the Medicare community nursing organization (CNO) demonstration project.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. EXTENSION OF MEDICARE COMMUNITY NURSING ORGANIZATION (CNO) DEMONSTRATION

PROJECT.

(a) IN GENERAL.—Section 532(b)(2) of the Medicare, Medicaid, and SCHIP Balanced Budget Refinement

Act of 1999 (113 Stat. 1501A–388), as enacted into law

12	(A) by striking "and" at the end of clause
13	(i);
14	(B) by striking the period at the end of
15	clause (ii) and inserting "; and; and
16	(C) by adding at the end the following new
17	clause:
18	"(iii) 2002 shall be the capitation rate
19	determined under clause (ii), increased by
20	the national per capita Medicare+Choice
21	growth percentage for 2002 determined
22	under section 1853(d)(6) of the Social Se-
23	curity Act (42 U.S.C. 1395w-23(d)(6)).";
24	(3) in subparagraph (B)(i)—
