A BILL

To amend the Public Health Service Act to provide for programs regarding ovarian cancer.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Ovarian Cancer
3 Research and Information Amendments of 2001”.

4 **SEC. 2. RESEARCH ON OVARIAN CANCER.**

5 Section 417B(b)(2) of the Public Health Service Act
6 is amended—

7 (1) by striking “CANCERS.—For the purpose
8 of” and all that follows through “417,” and inserting
9 the following: “CANCERS.—

10 “(A) For the purpose of carrying out sec-
11 tion 417(d),”; and

12 (2) by adding at the end the following subpara-
13 graph:

14 “(B)(i) For the purpose of carrying out re-
15 search under section 417(d) on ovarian cancer,
16 there are authorized to be appropriated
17 \$150,000,000 for fiscal year 2002, and such
18 sums as may be necessary for each of the fiscal
19 years 2003 and 2004. With respect to such pur-
20 pose, such authorizations of appropriations are
21 in addition to the authorizations of appropria-
22 tions established in subparagraph (A) and in
23 subsection (a).

24 “(ii) Of the amounts appropriated under
25 clause (i) for a fiscal year, the Director of the
26 Institute shall reserve 50 percent for research

1 described in such clause that does not involve
2 treatment or clinical trials, and 50 percent for
3 research described in such clause that does in-
4 volve treatment and clinical trials.

5 “(iii) In expending the amounts appro-
6 priated under clause (i) for a fiscal year, the
7 Director of the Institute shall give priority to
8 the following activities regarding ovarian can-
9 cer:

10 “(I) Developing a test for the early
11 detection of the cancer.

12 “(II) Research to identify precursor
13 lesions and research to determine the man-
14 ner in which benign conditions progress to
15 malignant status.

16 “(III) Research to determine the rela-
17 tionship between the cancer and endo-
18 metriosis.

19 “(IV) Ensuring that, in clinical re-
20 search on the cancer that is conducted or
21 supported by the Institute, appropriate
22 counseling is provided to women before the
23 women participate as subjects in the re-
24 search, including (subject to changes in the
25 applicable facts) informing women that

1 there may be a genetic basis to such can-
2 cer.”.

3 SEC. 3. PUBLIC INFORMATION AND EDUCATION ON OVARIAN CANCER.

5 Section 417(d)(4) of the Public Health Service Act
6 is amended by striking “section 413; and” and inserting
7 the following: “section 413, which programs shall include
8 programs on ovarian cancer that (subject to changes in
9 the applicable facts) provide information and education
10 regarding—

11 “(A) screening procedures for such cancer,
12 including the fact that there is not a procedure
13 that reliably provides for the early detection of
14 such cancer;

15 “(B) the fact that there may be a genetic
16 basis to such cancer;

19 “(D) the various treatments for such can-
20 cer and the extent to which the treatments are
21 effective; and”.

22 SEC. 4. MEMBERSHIP OF NATIONAL CANCER ADVISORY
23 BOARD.

24 The membership of the National Cancer Advisory
25 Board under section 406(h)(2) of the Public Health Serv-

1 ice Act shall include one or more individuals who are at
2 high risk for developing ovarian cancer.

3 **SEC. 5. EFFECTIVE DATE.**

4 This Act takes effect October 1, 2001, or upon the
5 date of the enactment of this Act, whichever occurs later.
