## A BILL

To authorize the Administrator of the Small Business Administration to provide relief to small business concerns that suffered substantial economic injury as a result of the terrorist attacks against the United States that occurred on September 11, 2001.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "American Small Busi-
- 5 ness Recovery Act of 2001".

#### 1 SEC. 2. REDUCED INTEREST RATES ON DISASTER LOANS.

- 2 The interest charged on any loan made under section
- 3 7(b) of the Small Business Act (15 U.S.C. 636(b)) may
- 4 not exceed a rate of 4 percent per year if such loan is
- 5 made to an eligible small business concern during the 1-
- 6 year period beginning on the date of the enactment of this
- 7 Act.

### 8 SEC. 3. DISASTER GRANT AUTHORITY.

- 9 The Administrator of the Small Business Administra-
- 10 tion may make a grant to any eligible small business con-
- 11 cern during the 1-year period beginning on the date of
- 12 the enactment of this Act.

### 13 SEC. 4. DISASTER LOAN FORGIVENESS AUTHORITY.

- 14 (a) IN GENERAL.—Upon application by an eligible
- 15 small business concern which is the recipient of a loan
- 16 made under the Small Business Act (15 U.S.C. 631 et
- 17 seq.), the Administrator of the Small Business Adminis-
- 18 tration may—
- 19 (1) if the loan was guaranteed by the Adminis-
- trator, undertake all or part of the small business
- 21 concern's obligation to make payments under such
- loan; or
- (2) if the loan was a direct loan made by the
- Administrator, discharge all or part of the indebted-
- 25 ness of the small business concern under such loan.

- 1 (b) APPLICATION PERIOD.—The Administrator may
- 2 accept applications under subsection (a) during the 1-year
- 3 period beginning on the date of the enactment of this Act.
- 4 SEC. 5. ELIGIBLE SMALL BUSINESS CONCERN.
- 5 For purposes of this Act, the term "eligible small
- 6 business concern" means a small business concern (as de-
- 7 fined in section 3(a) of the Small Business Act (15 U.S.C.
- 8 632(a))) that suffered substantial economic injury as a re-
- 9 sult of the terrorist attacks against the United States that
- 10 occurred on September 11, 2001.
