A BILL

To establish the Silver Scholarship program to provide transferable educational awards to individuals 55 years of age and older who perform certain volunteer services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SILVER SCHOLARSHIP PROGRAM.
- 4 Subtitle D of title I of the National and Community
- 5 Service Act of 1990 (42 U.S.C. 12601 et seq.) is amended
- 6 by adding at the end the following new section:
- 7 "SEC. 149. SILVER SCHOLARSHIP PROGRAM.
- 8 "(a) Establishment.—The Chief Executive Officer
- 9 is authorized to award grants to public agencies and pri-

- 1 vate nonprofit organizations with experience in admin-
- 2 istering volunteer programs (including the programs re-
- 3 ferred to or administered under title II of the Domestic
- 4 Volunteer Service Act of 1973) to provide scholarships of
- 5 not more than \$1,000 each in accordance with this sec-
- 6 tion.
- 7 "(b) Applications.—An eligible agency or organiza-
- 8 tion desiring a grant under this section shall submit to
- 9 the Chief Executive Officer an application in such form
- 10 and accompanied by such information as he may reason-
- 11 ably require.
- 12 "(c) Requirements for Scholarship.—A public
- 13 agency or nonprofit organization receiving a grant under
- 14 subsection (a) may award scholarships of \$1,000 to each
- 15 individual designated by a senior volunteer who has met
- 16 the following requirements:
- 17 "(1) Performed not less than 500 hours of vol-
- unteer services of the type established to be appro-
- priate under subsection (d)(2) during a 12-month
- 20 period (or a prorated amount for an individual who
- completes not less than 250 hours but less than 500
- hours in a 12-month period based on compelling per-
- 23 sonal circumstances)—
- 24 "(A) after having attained the age of 55
- 25 years; and

1	"(B) after the date of the enactment of
2	this section.
3	"(2) Received fewer than 2 scholarships under
4	this section within the 5-year period preceding the
5	date that the scholarship is awarded.
6	"(d) Criteria and Priorities.—The Chief Execu-
7	tive Officer shall—
8	"(1) establish criteria and priorities for award-
9	ing grants under this section and for the award by
10	grantees of scholarships under this section; and
11	"(2) establish which types of volunteer services
12	(including tutoring or mentoring in a school setting,
13	afterschool setting, or other community-based edu-
14	cational setting and assisting persons with special
15	needs to continue living independently) are appro-
16	priate to receive credit toward a scholarship awarded
17	under this section.
18	"(e) USE OF SCHOLARSHIPS.—A scholarship award-
19	ed under this section may be used—
20	"(1) by the recipient or any person designated
21	by the recipient;
22	"(2) only for qualified tuition and related ex-
23	penses, as defined in section 117 of the Internal
24	Revenue Code of 1986, and conditions set forth by
25	the Chief Executive Officer through regulation; and

1	"(3) not later than 7 years after award of the
2	scholarship.
3	"(f) Authorization of Appropriations.—
4	"(1) IN GENERAL.—There are authorized to be
5	appropriated for this section \$20,000,000 for the
6	first fiscal year beginning after the date of the en-
7	actment of this section and such sums as are nec-
8	essary for each fiscal year thereafter.
9	"(2) Use of funds.—Of the funds appro-
10	priated under paragraph (1)—
11	"(A) not more than 50 percent shall be
12	used for administrative purposes by the Chief
13	Executive Officer;
14	"(B) not less than 40 percent shall be
15	granted for use in awarding scholarships to vol-
16	unteers who have performed the hours required
17	for the scholarship providing tutoring or men-
18	toring in a school setting, afterschool setting, or
19	other community-based educational setting, as
20	defined in rules promulgated by the Corpora-
21	tion; and
22	"(C) not less than 10 percent shall be
23	granted for use in awarding scholarships to eli-
24	gible volunteers in assisting persons with special
25	needs to continue to live independently, includ-

ing those who are homebound, as defined inrules promulgated by the Corporation.".
