Mr. HANSEN introduced the following bill; which was referred to the Committee on Resources

A BILL

To authorize the establishment of a memorial to former President Ronald Reagan within the area in the District of Columbia referred to in the Commemorative Works Act as “Area I”, to provide for the design and construction of such memorial, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ronald Reagan Memo-
5 rial Act of 2001”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds the following:

1 (1) Ronald Reagan is an American hero deserving
2 of recognition by this and future generations of
3 Americans and visitors from around the world.

1 **SEC. 3. AUTHORIZATION OF RONALD REAGAN MEMORIAL;**2 **LOCATION AND DESIGN.**

3 (a) AUTHORIZATION OF RONALD REAGAN MEMO-

4 RIAL.—

5 (1) IN GENERAL.—The Ronald Reagan Memo-
6 rial Commission is authorized to establish the Ron-
7 ald Reagan Memorial in accordance with this Act,
8 on Federal lands administered by the National Park
9 Service in the District of Columbia.10 (2) LOCATION.—The memorial shall be situated
11 in a location that is—12 (A) recommended by the Ronald Reagan
13 Memorial Commission; and14 (B) in the area on the Mall west of the
15 Capitol and east of the Lincoln Memorial, and
16 within the area referred to in the Commemora-
17 tive Works Act (40 U.S.C. 1001 et seq.) as
18 Area I.19 (b) DUTIES OF THE NATIONAL CAPITAL MEMORIAL
20 COMMISSION AND THE SECRETARY OF THE INTERIOR.—21 The National Capital Memorial Commission and the Sec-
22 retary of the Interior shall assist the members of the Ron-
23 ald Reagan Memorial Commission—24 (1) in the preparation of a recommendation to
25 the Congress of a permanent location for the memo-
26 rial; and

3 (c) DETAIL OF DEPARTMENT OF THE INTERIOR EM-
4 PLOYEES.—The Secretary of the Interior shall detail to
5 the Ronald Reagan Memorial Commission such support
6 staff as are necessary to assist the members of the com-
7 mission in carrying out its responsibilities.

8 (d) BEGINNING OF PROCESS.—The Ronald Reagan
9 Memorial Commission shall begin the process of recom-
10 mending a location and selecting a design for the memorial
11 no later than six months after the date of enactment of
12 this Act.

13 (e) MARKER.—

18 (2) REQUIREMENTS.—The marker shall be—

19 (A) installed by the Secretary no later than
20 three months after the date of the enactment of
21 a law approving the location for the memorial;
22 (B) no smaller than three feet square and
23 constructed of durable material suitable to the
24 outdoor environment; and

(C) maintained at the location by the Secretary until the memorial is completed, dedicated, and open to the public.

4 (f) RELATIONSHIP TO THE COMMEMORATIVE WORKS
5 ACT.—Sections 3(c), 7(a)(2), and 8(a)(1) of the Com-
6 memorative Works Act (40 U.S.C. 1003(c), 1007(a)(2),
7 1008(a)(1)) shall not apply to the memorial.

8 SEC. 4. RONALD REAGAN MEMORIAL COMMISSION.

9 (a) ESTABLISHMENT.—There is established a com-
10 mission, to be known as the Ronald Reagan Memorial
11 Commission. The commission shall—

12 (1) be comprised of—

13 (A) the Chairman of the National Capital
14 Memorial Commission;

15 (B) one member appointed by the Speaker
16 of the House of Representatives by no later
17 than six months after the date of the enactment
18 of this Act; and

19 (C) one member appointed by the majority
20 leader of the Senate by no later than six
21 months after the date of the enactment of this
22 Act;

23 (2) be chaired by one of its members, to be des-
24 ignated jointly by the Speaker of the House of Rep-
25 resentatives and the majority leader of the Senate;

4 (4) be exempt from the Federal Advisory Com-
5 mittee Act (5 U.S.C. App.).

6 (b) DUTIES.—The Ronald Reagan Memorial Com-
7 mission shall—

24 (c) TERMINATION.—The commission shall terminate
25 not later than 90 days after completion of the memorial.

1 **SEC. 5. DEFINITIONS.**

2 In this Act:

3 (1) MEMORIAL.—The term “memorial” means
4 the Ronald Reagan Memorial authorized by this Act.5 (2) SECRETARY.—The term “Secretary” means
6 the Secretary of the Interior.
