Mr. MALONEY of Connecticut introduced the following bill; which was referred
to the Committee on Ways and Means

A BILL

To provide for the reliquidation of certain entries of
vanadium carbides and vanadium carbonitride.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. RELIQUIDATION OF CERTAIN ENTRIES OF VA-**
4 **NADIUM CARBIDES AND VANADIUM**
5 **CARBONITRIDE.**

6 (a) IN GENERAL.—Notwithstanding sections 514 and
7 520 of the Tariff Act of 1930 (19 U.S.C. 1514 and 1520)
8 or any other provision of law and subject to the provisions
9 of subsection (b), the United States Customs Service,
10 shall, not later than 180 days after receipt of the request

1 described in subsection (b), liquidate or reliquidate each
2 entry described in subsection (d) containing any merchan-
3 dise which, at the time of its entry or release from ware-
4 house for consumption, was classified under subheading
5 2849.90.50 of the Harmonized Tariff Schedule of the
6 United States, at the rate of duty that would have been
7 applicable to such merchandise if the merchandise had
8 been liquidated or reliquidated at the Special rate of duty
9 for such subheading 2849.90.50 on the date of entry,
10 without regard to the country of origin of such merchan-
11 dise.

12 (b) REQUESTS.—Liquidation or reliquidation may be
13 made under subsection (a) with respect to an entry de-
14 scribed in subsection (d) only if a request therefor is filed
15 with the Customs Service within 90 days after the date
16 of the enactment of this Act and the request contains suf-
17 ficient information to enable the Customs Service to locate
18 the entry or reconstruct the entry if it cannot be located.

19 (c) PAYMENT OF AMOUNTS OWED.—Any amounts
20 owed by the United States pursuant to the liquidation or
21 reliquidation of any entry under subsection (a) shall be
22 paid not later than 90 days after the date of such liquida-
23 tion or reliquidation.
