1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Veterans Medical Care
- 3 Improvement and Equity Act of 2002".

- 5 Congress makes the following findings:
- 6 (1) The current Veterans Equitable Resource 7 Allocation (VERA) system fails to adequately dis-8 tribute Department of Veterans Affairs medical care 9 resources to where veterans actually reside in ac-10 cordance with section 429 of Public Law 104–204
- 12 (2) The number of veterans seeking medical 13 care in the Department of Veterans Affairs health 14 care system is far outstripping the ability of that 15 system to provide care to all veterans in need.
 - (3) There are currently thousands of Category
 1 through 6 veterans with service-connected disabilities who are on waiting lists to enroll in the Department of Veterans Affairs health care system.
 - (4) There are Category 7 veterans with serious health care needs who are enrolled or awaiting enrollment in the Department of Veterans Affairs health care system.

- 16 SEC. 4. PRIORITIZATION FOR ENROLLMENT AND CARE.
- 17 The Secretary of Veterans Affairs shall provide for
- 18 priority in the enrollment of veterans in the Department
- 19 of Veterans Affairs health care system, and in the fur-
- 20 nishing of care and services through that system, in ac-
- 21 cordance with the following categories, with priority in the
- 22 order listed:
- 23 (1) Any veteran with an emergent or urgent
- care need.

- 1 (2) Any veteran described in any of paragraphs
 2 (1) through (6) of section 1705(a) of title 38,
 3 United States Code, and any veteran described in
 4 paragraph (7) of such section who has a serious
 5 health care need that if not treated would place the
 6 veteran's life in jeopardy.
- 7 (3) Any veteran not described in paragraph (1) 8 or (2).

9 SEC. 5. EFFECTIVE DATE.

This Act shall take effect upon enactment and shall apply with respect to funds appropriated for fiscal year 2003 and thereafter.
