A BILL

To provide that land which is owned by the Seminole Tribe of Florida but which is not held in trust by the United States for the Tribe may be mortgaged, leased, or transferred by the Tribe without further approval by the United States.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. APPROVAL NOT REQUIRED TO VALIDATE CER-**
4 **TAIN LAND TRANSACTIONS.**

5 *(a) TRANSACTIONS.—The Seminole Tribe of Florida*
6 *may mortgage, lease, sell, convey, warrant, or otherwise*
7 *transfer all or any part of any interest in any real property*
8 *that—*

9 *(1) was held by the Tribe on September 1, 2002;*
10 *and*

11 *(2) is not held in trust by the United States for*
12 *the benefit of the Tribe.*

13 *(b) NO FURTHER APPROVAL REQUIRED.—Trans-*
14 *actions under subsection (a) shall be valid without further*
15 *approval, ratification, or authorization by the United*
16 *States.*

17 *(c) TRUST LAND NOT AFFECTED.—Nothing in this*
18 *section is intended or shall be construed to—*

19 *(1) authorize the Seminole Tribe of Florida to*
20 *mortgage, lease, sell, convey, warrant, or otherwise*
21 *transfer all or any part of an interest in any real*
22 *property that is held in trust by the United States for*
23 *the benefit of the Tribe; or*

24 *(2) affect the operation of any law governing*
25 *mortgaging, leasing, selling, conveying, warranting,*

- 1 *or otherwise transferring any interest in such trust*
2 *land.*

Amend the title so as to read: “A bill to provide that real property interests owned by the Seminole Tribe of Florida on September 1, 2002, which are not held in trust by the United States for the Tribe may be obligated or transferred by the Tribe without further approval by the United States.”.
