A BILL

- To require the Consumer Product Safety Commission to amend its flammability standards for children's sleepwear under the Flammable Fabrics Act.

 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Children's Safe
 - 5 Sleepwear and Burn Prevention Act of 2002".
 - 6 SEC. 2. AMENDMENTS TO CHILDREN'S SLEEPWEAR FLAM-
 - 7 MABILITY REGULATIONS.
 - 8 (a) In General.—The Consumer Product Safety
 - 9 Commission (in this Act referred to as the "Commission")

23	at a minimum, infant and children's garment sizes
24	2 through 6X, as such sizes are defined by the De-
25	partment of Commerce Voluntary Product Standard

- 1 identified Commercial (previously as Standard 2 CS151–50 "Body Measurements for the Sizing of Apparel for Infants, Babies, Toddlers, and Chil-3 4 dren")), including children's clothing used with some 5 regularity as sleepwear, such as— (A) "togs"; 6 (B) "onesies"; 7 8 (C) body suits with snaps at the bottom 9 for easy access to a diaper; (D) all-in-one "bunny" suits with enclosed 10 11 feet; and 12 (E) any garments sized for children ages 0 13 through 7 years with cartoon characters or 14 symbols that the Commission finds are particu-15 larly attractive to young children. 16 (b) RULEMAKING.—Notwithstanding any other provision of law, not later than 180 days after the date of en-17 18 actment of this Act, the Commission shall promulgate reg-
