## A BILL

To increase the penalties to be imposed for a violation of fire regulations applicable to the public lands, National Park System lands, or National Forest System lands when the violation results in damage to public or private property, to specify the purpose for which collected fines may be used, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2 tives of the United States of America in Congress assembled,*

3 **SECTION 1. PENALTIES FOR VIOLATION OF PUBLIC LAND**

4       **FIRE REGULATIONS RESULTING IN PROPERTY  
5 DAMAGE.**

6       *(a) INCREASED PENALTIES ON INTERIOR LANDS.—*

7       *Notwithstanding section 303(a) of the Federal Land Policy  
8 and Management Act of 1976 (43 U.S.C. 1733(a)) or section  
9 3 of the Act of August 25, 1916 (16 U.S.C. 3), a violation  
10 of the rules regulating the use of fire by visitors and other  
11 users of lands administered by the Bureau of Land Manage-  
12 ment or National Park System lands shall be punished by  
13 a fine of not less than \$1,000 or imprisonment for not more  
14 than one year, or both, if the violation results in damage  
15 to public or private property.*

16       *(b) INCREASED PENALTIES ON NATIONAL FOREST  
17 SYSTEM LANDS.—Notwithstanding the eleventh undesign-*

1 nated paragraph under the heading “SURVEYING THE PUB-  
2 LIC LANDS” of the Act of June 4, 1897 (16 U.S.C. 551),  
3 a violation of the rules regulating the use of fire by visitors  
4 and other users of National Forest System lands shall be  
5 punished by a fine of not less than \$1,000 or imprisonment  
6 for not more than one year, or both, if the violation results  
7 in damage to public or private property.

8 (c) USE OF COLLECTED FINES.—Any moneys received  
9 by the United States as a result of a fine imposed for a  
10 violation of fire rules applicable to lands administered by  
11 the Bureau of Land Management, National Park System  
12 lands, or National Forest System lands shall be available  
13 to the Secretary of the Interior or the Secretary of Agri-  
14 culture, as the case may be, without further appropriation  
15 and until expended, for the following purposes:

16 (1) To cover the cost to the United States of any  
17 improvement, protection, or rehabilitation work ren-  
18 dered necessary by the action that resulted in the fine.

19 (2) To reimburse the affected agency for the cost  
20 of the response to the action that resulted in the fine,  
21 including investigations, damage assessments, and  
22 legal actions.

23 (3) To increase public awareness of rules, regula-  
24 tions, and other requirements regarding the use of fire  
25 on public lands.
