A BILL

- To provide for the conveyance of the land containing the Mount Wilson Observatory in the Angeles National Forest, California, to the Mount Wilson Institute, the non-profit organization operating the observatory.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Mount Wilson Observ-
 - 5 atory Preservation and Enhancement Act".

- 1 SEC. 2. LAND CONVEYANCE, MOUNT WILSON OBSERV-
- 2 ATORY, ANGELES NATIONAL FOREST, CALI-
- FORNIA.
- 4 (a) Conveyance Required.—The Secretary of Ag-
- 5 riculture shall convey, without consideration, to the Mount
- 6 Wilson Institute all right, title, and interest of the United
- 7 States in and to a parcel of real property, including any
- 8 improvements thereon that are administered by the Forest
- 9 Service, consisting of approximately 110 acres in the An-
- 10 geles National Forest in the State of California and con-
- 11 taining the Mount Wilson Observatory and related road-
- 12 ways, parking lots, and public facilities that are adminis-
- 13 tered by the Forest Service, as depicted on the map enti-
- 14 tled "Mount Wilson Observatory Conveyance" and dated
- 15 June 17, 2002.
- 16 (b) Purpose of Conveyance.—The Mount Wilson
- 17 Institute operates the Mount Wilson Observatory, and the
- 18 land on which the observatory is situated is leased from
- 19 the Forest Service. The purpose of the conveyance under
- 20 subsection (a) is to recognize the unique qualifications of
- 21 the Mount Wilson Institute as the best possible steward
- 22 to operate, maintain, preserve, and enhance the observ-
- 23 atory for scientific, educational, historical, and other pub-
- 24 lie purposes.
- 25 (c) CONDITION OF CONVEYANCE.—The conveyance
- 26 under subsection (a) shall be subject to the terms of the

- 1 existing lease between the Forest Service and the Carnegie
- 2 Institution of Washington regarding the land to be con-
- 3 veyed, and the Mount Wilson Institute shall assume the
- 4 obligations of the Forest Service under the lease.
- 5 (d) REVERSION.—If the Secretary determines at any
- 6 time that the land conveyed under subsection (a) is not
- 7 being used for scientific, educational, historical, or other
- 8 public purposes, all right, title, and interest in and to that
- 9 land (including any improvements thereon that were con-
- 10 veyed by the United States under subsection (a)) shall re-
- 11 vert to the United States, and the United States shall have
- 12 the right of immediate entry thereon. If such a reversion
- 13 occurs before the termination of the lease referred to in
- 14 subsection (c), the lease shall continue between the Forest
- 15 Service and the Carnegie Institution of Washington.
