A BILL

To amend title XIX of the Social Security Act to expand the current provision of medical assistance to certain uninsured women who have been screened and found to have breast or cervical cancer to also cover ovarian and uterine cancer.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Ovarian and Uterine
- 5 Cancer Prevention and Treatment Act of 2002".

1	SEC. 2. OPTIONAL MEDICAID COVERAGE OF CERTAIN
2	OVARIAN AND UTERINE CANCER PATIENTS.
3	(a) Coverage.—Section 1902 of the Social Security
4	Act (42 U.S.C. 1396a) is amended—
5	(1) in subsection $(a)(10)(A)(ii)(XVIII)$, by
6	striking "breast or cervical" and inserting "breast,
7	cervical, ovarian, or uterine";
8	(2) in subsection (a)(10), in the clause (XIV)
9	following subparagraph (G), by striking "breast and
10	cervical" and inserting "breast, cervical, ovarian,
11	and uterine"; and
12	(3) in subsection (aa)(3), by inserting before
13	the semicolon at the end the following: "or have
14	been screened for ovarian and uterine cancer under
15	an appropriate program of the Centers for Disease
16	Control and Prevention to screen women for ovarian
17	and uterine cancer as a preventive health measure
18	and need treatment for ovarian or uterine cancer".
19	(b) Presumptive Eligibility.—Section 1920B of
20	such Act (42 U.S.C. 1396r–1b) is amended—
21	(1) in the heading, by striking "BREAST OR
22	CERVICAL" and inserting "BREAST, CERVICAL, OVAR-
23	IAN, OR UTERINE"; and
24	(2) in subsection (a), by striking "breast or cer-
25	vical" and inserting "breast, cervical, ovarian, or
26	uterine".

- 1 (c) Effective Date.—The amendments made by
- 2 this section apply to medical assistance for items and serv-
- 3 ices furnished on or after October 1, 2002, without regard
- 4 to whether final regulations to carry out such amendments

5 made been promulgated by such date.
