A BILL

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Naturally Occurring
- 5 Retirement Community (NORC) Support Act".
- 6 SEC. 2. AMENDMENTS.
- 7 The Older Americans Act of 1995 (42 U.S.C. 3001
- 8 et seq) is amended—
- 9 (1) by inserting before section 401 the fol-
- lowing:

1	"TITLE IV—RESEARCH, TRAIN-
2	ING, AND RELATED MAT-
3	TERS",
4	and
5	(2) by inserting after section 421 the following:
6	"SEC. 422. NATURALLY OCCURRING RETIREMENT COMMU-
7	NITIES.
8	"(a) Program Authorized.—The Assistant Sec-
9	retary shall make grants to public and private agencies
10	and organizations to provide comprehensive supportive
11	services to older individuals who reside in noninstitutional
12	residences (excluding residences for which assistance is
13	provided under section 202 of the National Housing Act
14	of 1959 (12 U.S.C. 1701q)) in naturally occurring retire-
15	ment communities, for purposes of enhancing the quality
16	of life of such individuals and reducing the need to institu-
17	tionalize such individuals.
18	"(b) USE OF FUNDS.—In each fiscal year for which
19	funds are appropriated to carry out this section, the As-
20	sistant Secretary shall—
21	(1) make grants to not fewer than 5, and not
22	more than 8, public and private agencies and organi-
23	zations that submit to the Assistant Secretary an
24	application in such form, and containing such infor-
25	mation, as the Assistant Secretary may require by

- 1 rule, including an assurance that the applicant will
- 2 use such grant to supplement and not supplant re-
- 3 sources otherwise available to such applicant to pro-
- 4 vide supportive services to older individuals; and
- 5 "(2) give priority to agencies and organizations
- 6 that provided comprehensive supportive services in
- fiscal year 2002 to older individuals who resided in
- 8 noninstitutional residences (excluding residences for
- 9 which assistance is provided under section 202 of
- the National Housing Act of 1959 (12 U.S.C.
- 11 1701q)) in naturally occurring retirement commu-
- 12 nities, for purposes of enhancing the quality of life
- of such individuals and reducing the need to institu-
- tionalize such individuals.
- 15 "(c) Definition.—For purposes of this section, the
- 16 term 'naturally occurring retirement community' means a
- 17 geographical area in which not less than 40 percent of the
- 18 noninstitutional residences are occupied for not less than
- 19 10 years by heads of households who are older individuals,
- 20 but does not include residences for which assistance is pro-
- 21 vided under section 202 of the National Housing Act of
- 22 1959 (12 U.S.C. 1701q)).
- 23 "(d) Report.—Not later than 3 years after the 1st
- 24 fiscal year for which funds are appropriated to carry out
- 25 this section, the Assistant Secretary shall—

1	"(1) carry out an evaluation of the progress
2	and development of supportive services provided with
3	grants made under this section; and
4	"(2) submit to the Congress a report—
5	"(A) summarizing the results of such eval-
6	uation; and
7	"(B) containing such recommendations as
8	the Assistant Secretary considers to be appro-
9	priate.
10	"(e) Authorization of Appropriations.—There
11	are authorized to be appropriated to carry out this section,
12	\$10,000,000 for fiscal year 2003 and such sums as may
13	be necessary for fiscal years 2004, 2005, 2006, and
14	2007 ''
