A BILL

To amend title 38, United States Code, to provide for certain servicemembers to become eligible for educational assistance under the Montgomery GI Bill.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Montgomery GI Bill
- 5 Enhancement Act of 2002".

- 4 (a) IN GENERAL.—Chapter 30 of title 38, United
- 5 States Code, is amended by inserting after section 3018C
- 6 the following new sections:

7 "§ 3018D. Opportunity for certain active-duty per-

- 8 sonnel to enroll
- 9 "(a)(1) Notwithstanding any other provision of this
- 10 chapter, during the one-year period beginning on the date
- 11 of the enactment of this section, a qualified individual (de-
- 12 scribed in subsection (b)) may make an irrevocable elec-
- 13 tion under this section to become entitled to basic edu-
- 14 cational assistance under this chapter.
- 15 "(2) The Secretary of each military department shall
- 16 provide for procedures for a qualified individual to make
- 17 an irrevocable election under this section in accordance
- 18 with regulations prescribed by the Secretary of Defense
- 19 for the purpose of carrying out this section or which the
- 20 Secretary of Transportation shall provide for such purpose
- 21 with respect to the Coast Guard when it is not operating
- 22 as a service in the Navy.
- 23 "(b) A qualified individual referred to in subsection
- 24 (a) is an individual who meets each of the following re-
- 25 quirements:

- "(1) The individual first became a member of 1 2 the Armed Forces or first entered on active duty as 3 a member of the Armed Forces before July 1, 1985.
 - "(2) The individual has served on active duty without a break in service since the date the individual first became such a member or first entered on active duty as such a member.
- 8 "(3) The individual, before applying for benefits 9 under this section, has completed the requirements 10 of a secondary school diploma (or equivalency certificate) or has successfully completed (or otherwise re-12 ceived academic credit for) the equivalent of 12 se-13 mester hours in a program of education leading to 14 a standard college degree.
 - "(4) The individual, when discharged or released from active duty, is discharged or released therefrom with an honorable discharge.
- 18 "(c)(1) Subject to the succeeding provisions of this 19 subsection, with respect to a qualified individual who 20 makes an election under this section to become entitled 21 to basic educational assistance under this chapter—
- "(A) the basic pay of the qualified individual 22 23 shall be reduced (in a manner determined by the 24 Secretary concerned) until the total amount by 25 which such basic pay is reduced is \$2,700; and

2	duced before the qualified individual's discharge or

19	"(B) Nothing in subparagraph (A) shall be construed
20	as modifying the period of eligibility for and entitlement
21	to basic educational assistance under this chapter applica-
22	ble under section 3031 of this title.
23	"(d) With respect to qualified individuals referred to
24	in subsection (c)(1)(B), no amount of educational assist-

- 1 ance allowance under this chapter shall be paid to the
- 2 qualified individual until the earlier of the date on which—
- 3 "(1) the Secretary concerned collects the appli-
- 4 cable amount under clause (i) of such subsection; or
- 5 "(2) the retired or retainer pay of the qualified
- 6 individual is first reduced under clause (ii) of such
- 7 subsection.
- 8 "(e) The Secretary, in conjunction with the Secretary
- 9 of Defense, shall provide for notice of the opportunity
- 10 under this section to elect to become entitled to basic edu-
- 11 cational assistance under this chapter.".
- 12 (b) Conforming Amendments.—Section
- 13 3017(b)(1) of such title is amended—
- 14 (1) in subparagraphs (A) and (C), by striking
- 15 "or 3018C(e)" and inserting "3018C(e), or
- 16 3018D(c)"; and
- 17 (2) in subparagraph (B), by inserting "or
- 3018D(e)" after "under section 3018C(e)".
- 19 (c) CLERICAL AMENDMENT.—The table of sections
- 20 at the beginning of chapter 30 of such title is amended
- 21 by inserting after the item relating to section 3018C the
- 22 following new item:

"3018D. Opportunity for certain active-duty personnel to enroll.".
