## A BILL

To name the Department of Veterans Affairs outpatient clinic in Horsham, Pennsylvania, as the "Victor J. Saracini Department of Veterans Affairs Outpatient Clinic".

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. FINDINGS.
- 4 Congress finds the following:
- 5 (1) Victor J. Saracini was an esteemed, deco-
- 6 rated officer with the United States Navy, ending

- his military career in the Naval Reserve at Naval
   Air Station Willow Grove, Pennsylvania.
- 3 (2) Joining United Airlines in 1985, Mr. 4 Saracini worked his way up the ranks to captain of

the United Airline's Boeing 757–767 fleet.

- 6 (3) Victor Saracini was the captain of United 7 Airlines Flight 175, one of the four commercial jets 8 hijacked by terrorists on September 11, 2001.
- 9 (4) At 9:05 a.m., the Los Angeles-bound air-10 plane flew into the South Tower of the World Trade 11 Center, killing all people onboard, including Captain 12 Victor Saracini.
- 13 (5) On September 11, 2001, the United States
  14 lost Victor Saracini, a devoted aviator, a distin15 guished veteran, and a proud defender of America's
  16 freedom.

- 18 PATIENT CLINIC, HORSHAM, PENNSYLVANIA.
- 19 The Department of Veterans Affairs outpatient clinic
- 20 located in Horsham, Pennsylvania, shall after the date of
- 21 the enactment of this Act be known and designated as the
- 22 "Victor J. Saracini Department of Veterans Affairs Out-
- 23 patient Clinic". Any reference to such outpatient clinic in
- 24 any law, regulation, map, document, record, or other
