## A BILL

To authorize the Secretary of the Interior to convey certain water distribution systems of the Cachuma Project, California, to the Carpinteria Valley Water District and the Montecito Water District.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

#### SECTION 1. SHORT TITLE.

- This Act may be cited as the "Carpinteria and
- 3 Montecito Water Distribution Systems Conveyance Act of
- 4 2002".

#### 5 SEC. 2. CONVEYANCE OF WATER DISTRIBUTION SYSTEMS

- 6 OF THE CACHUMA PROJECT, CALIFORNIA.
- 7 (a) In General.—The Secretary of the Interior—
- 8 (1) may convey to the Carpinteria Valley Water
- 9 District, located in Santa Barbara County, Cali-
- fornia, all right, title, and interest of the United
- States in and to the Carpinteria Distribution System
- of the Cachuma Project, California, consistent with
- the terms and conditions set forth in the agreement
- 14 entitled "Agreement Between the United States and
- the Carpinteria Valley Water District to Transfer
- 16 Title to the Federally Owned Distribution System to
- 17 the Carpinteria Valley Water District" (Agreement
- 18 No. 00–XC–20–0364); and
- 19 (2) may convey to the Montecito Water Dis-
- trict, located in Santa Barbara County, California,
- all right, title, and interest of the United States in
- and to the Montecito Water Distribution System of
- 23 the Cachuma Project, California, consistent with the
- terms and conditions set forth in the agreement en-
- 25 titled "Agreement Between the United States and
- the Montecito Water District to Transfer Title to

- 1 the Federally Owned Distribution System to the
- 2 Montecito Water District' (Agreement No. 01–XC–
- 3 20-0365).
- 4 (b) Liability.—Effective upon the date of convey-
- 5 ance of a distribution system under this section, the
- 6 United States shall not be held liable by any court for
- 7 damages of any kind arising out of any act, omission, or
- 8 occurrence relating to the distribution system, except for
- 9 damages caused by acts of negligence committed by the
- 10 United States or by its employees or agents prior to the
- 11 date of conveyance. Nothing in this section increases the
- 12 liability of the United States beyond that provided in chap-
- 13 ter 171 of title 28, United States Code (popularly known
- 14 as the Federal Tort Claims Act) on the date of the enact-
- 15 ment of this Act.
- 16 (c) Benefits.—After conveyance of a water distribu-
- 17 tion system to the Carpinteria Valley Water District or
- 18 the Montecito Water District under this section—
- 19 (1) such water distribution system shall not be
- 20 considered to be a part of a Federal reclamation
- 21 project; and
- 22 (2) such water district shall not be eligible to
- receive any benefits with respect to any facility com-
- prising that distribution system, except benefits that
- would be available to a similarly situated person

- 1 with respect to such a facility that is not part of a
- 2 Federal reclamation project.
