- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Mandatory Restitution
- 5 for Corporate Abuses Act of 2002".
- 6 SEC. 2. MANDATORY RESTITUTION.
- 7 (a) In General.—Chapter 63 of title 18, United
- 8 States Code, is amended by adding at the end the fol-
- 9 lowing:

- 2 "(a) IN GENERAL.—Notwithstanding section 3663 or
- 3 3663A, and in addition to any other civil or criminal pen-
- alty authorized by law, the court shall order restitution 4
- 5 to all victims of any offense under section 1341, 1342,
- 1343, 1344, or 1348. 6
- 7 "(b) Scope and Nature of Order.—
- "(1) DIRECTIONS.—The order of restitution 8 9 under this section shall direct the defendant to pay 10 to the victim (through the appropriate court mecha-11 nism) the full amount of the victim's losses as deter-
- 12 mined by the court pursuant to paragraph (2).
