A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. USE OF CERTAIN FUNDS UNDER THE INDIVID-**
2 **UALS WITH DISABILITIES EDUCATION ACT.**

3 Section 613(a)(2)(C) of the Individuals with Disabil-
4 ities Education Act (20 U.S.C. 1413(a)(2)(C)) is
5 amended—

6 (1) by redesignating clause (ii) as clause (iii);

7 and

8 (2) by inserting after clause (i) the following:

9 “(ii) If a local educational agency
10 chooses to utilize the authority under
11 clause (i) to treat as local funds up to 20
12 percent of the amount of funds the agency
13 receives under this part that exceeds the
14 amount it received under this part for the
15 previous fiscal year, then the agency shall
16 use those local funds to provide additional
17 funding for programs under the Elemen-
18 tary and Secondary Education Act of
19 1965, including, but not limited to, pro-
20 grams that address school safety, teacher
21 quality and professional development, be-
22 fore and after school learning opportuni-
23 ties, comprehensive school reform and lit-
24 eracy, class size reduction, school construc-
25 tion and modernization, or related edu-

1 cation programs authorized under Federal
2 or State law.”.
