## A BILL

To provide for the establishment of an Internet site on Federal financial assistance.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "People's Access to Gov-
- 5 ernment Information Act".
- 6 SEC. 2. INTERNET SITE.
- 7 (a) Establishment of Internet Site.—The Sec-
- 8 retary of Commerce shall establish and maintain a search-
- 9 able Internet site for the purpose of providing to the public
- 10 ready access to information on Federal financial assist-

1	ance, including grants, loans, loan guarantees, scholar-
2	ships, and fellowships.
3	(b) Contents of Internet Site.—The Internet
4	Site shall contain the following:
5	(1) A description of each type of grant, loan
6	loan guarantee, scholarship, or fellowship provided
7	by each Federal agency, including a description of—
8	(A) the type of assistance;
9	(B) any Catalog of Federal Domestic As-
10	sistance program number;
11	(C) the objectives of the assistance;
12	(D) any restriction on use of the assist-
13	ance;
14	(E) any eligibility requirements;
15	(F) the application and award process, in-
16	cluding preapplication coordination, application
17	procedures, award procedures, any application
18	deadlines, a range of time required for approval
19	or disapproval of applications, any application
20	appeal procedures, and procedures for renewal
21	of assistance;
22	(G) assistance considerations, including
23	formula and matching requirements and length
24	and time phasing of assistance;

1	(H) post assistance requirements, includ-
2	ing reports, audits, and records;
3	(I) program accomplishments;
4	(J) information contacts;
5	(K) related programs;
6	(L) examples of funded projects;
7	(M) regulations and guidelines; and
8	(N) related literature.
9	(2) A direct link to any application that is
10	available online, or a statement that no such applica-
11	tion is available, for each type of grant, loan, loan
12	guarantee, scholarship, or fellowship that is referred
13	to in paragraph (1).
14	(3) A general explanation of how to apply for
15	a loan, including a general comparison of application
16	procedures for and terms of Federal Government
17	loans versus private loans.
18	(4) Information on how nonprofit organizations
19	may obtain surplus equipment from the Federal
20	Government.
21	(5) Direct links to other Federal Internet sites
22	with information on grants, loans, loan guarantees,
23	scholarships, or fellowships, including any such sites
24	maintained by or on behalf of a Federal financial as-
25	sistance agency.
