## A BILL

To suspend for two years the certification procedures under section 490(b) of the Foreign Assistance Act of 1961 in order to foster greater multilateral cooperation in international counternarcotics programs, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-  
2       tives of the United States of America in Congress assembled,*

3       **SECTION 1. TWO-YEAR SUSPENSION OF DRUG CERTIFI-  
4       CATION PROCEDURES.**

5       (a) FINDINGS.—Congress makes the following find-  
6       ings:

1 (1) Drug trafficking is a transnational phe-  
2 nomenon and thus requires international cooperation  
3 to fight and defeat this problem.

4 (2) The international drug trade poses a direct  
5 threat to the United States and to international ef-  
6 forts to promote democracy, economic stability,  
7 human rights, and the rule of law.

11 (4) Worldwide drug trafficking generates reve-  
12 nues estimated at \$400,000,000,000 annually.

19 (6) Such unilateral review is counter to the  
20 principle of equality among nations and contradicts  
21 the spirit of cooperation between nations.

22 (7) Countries must address drug trafficking by  
23 coordinating their efforts, particularly through peri-  
24 odic meetings of senior government officials and de-

1       veloping appropriate anti-drug strategies while re-  
2       specting the sovereignty of nations.

3       (b) SENSE OF CONGRESS.—It is the sense of Con-  
4       gress that—

5               (1) many governments are extremely concerned  
6       with the national security threat posed by illicit drug  
7       production, distribution, and consumption, and  
8       crimes related thereto, particularly those in the  
9       Western Hemisphere;

10              (2) an enhanced multilateral strategy should be  
11       developed among drug producing, transit, and con-  
12       suming nations designed to improve cooperation with  
13       respect to the investigation and prosecution of drug  
14       related crimes, and to make available information on  
15       effective drug education and drug treatment;

16              (3) the President should at the earliest feasible  
17       date in 2001 convene a conference of heads of state  
18       of major illicit drug producing countries, major drug  
19       transit countries, and major money laundering coun-  
20       tries to present and review country by country drug  
21       reduction and prevention strategies relevant to the  
22       specific circumstances of each country, and agree to  
23       a program and timetable for implementation of such  
24       strategies; and

1 (4) not later than one year after the date of the  
2 enactment of this Act, the President should transmit  
3 to Congress legislation to implement a proposed  
4 multilateral strategy to achieve the goals referred to  
5 in paragraph (2), including any amendments to ex-  
6 isting law that may be required to implement that  
7 strategy.

8        (c) TWO-YEAR SUSPENSION OF DRUG CERTIFI-  
9 CATION PROCESS.—(1) Subsections (a) through (g) of sec-  
10 tion 490 of the Foreign Assistance Act of 1961 (22 U.S.C.  
11 2291j), relating to annual certification procedures for as-  
12 sistance for certain drug producing countries and drug  
13 transit countries, shall not apply in the first two calendar  
14 years beginning after the date of enactment of this Act.

15 (2) Notwithstanding any provision of paragraph (1),  
16 section 489 of the Foreign Assistance Act of 1961 (22  
17 U.S.C. 2291h), relating to the international narcotics con-  
18 trol strategy report, and section 490(h) of that Act (22  
19 U.S.C. 2291j(h)), relating to determinations of major  
20 drug transit countries and major illicit drug producing  
21 countries, shall continue to apply in the two calendar years  
22 referred to in that paragraph.
