## A BILL

To provide for the establishment of the National Coast  
Guard Museum on Federal lands administered by the  
Coast Guard.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “National Coast Guard  
5       Museum Act of 2001”.

1 **SEC. 2. FINDINGS.**

2 The Congress finds the following:

3 (1) There is no national museum to commemo-  
4 rate and honor the Coast Guard's history, mission,  
5 personnel, and traditions or those of its predecessor  
6 services and agencies.

7 (2) There should be established a National  
8 Coast Guard Museum to commemorate the 210  
9 years of national maritime and military history of  
10 the Coast Guard and its predecessor services and  
11 agencies.

12 **SEC. 3. DEFINITIONS.**

13 In this Act:

14 (1) ASSOCIATION.—The term “Association”  
15 means the National Coast Guard Museum Associa-  
16 tion (a nonprofit corporation established under the  
17 laws of the State of Massachusetts), or a similar or-  
18 ganization.

19 (2) MUSEUM.—The term “Museum” means the  
20 National Coast Guard Museum established under  
21 sections 4(a).

22 (3) COMMANDANT.—The term “Commandant”  
23 means the Commandant of the Coast Guard.

24 (4) FUND.—The term “Fund” means the Na-  
25 tional Coast Guard Museum Fund established under  
26 section 5(a).

1 **SEC. 4. NATIONAL COAST GUARD MUSEUM.**

2 (a) ESTABLISHMENT.—The Commandant may, in ac-  
3 cordance with this section, establish, operate, and main-  
4 tain a National Coast Guard Museum on Federal lands  
5 that are administered by the Coast Guard and specified  
6 by the Commandant.

7 (b) CONSTRUCTION.—

8 (1) LICENSE.—The Commandant may grant a  
9 license to the Association authorizing the Association  
10 to construct facilities for the Museum on the land  
11 specified under subsection (a).

12 (2) TERMS.—The license under this subsection  
13 shall include terms that establish the following:

14 (A) Upon completion of construction of fa-  
15 cilities under the license, the Association shall  
16 donate such facilities, including any associated  
17 improvements, fixtures, and related personal  
18 property, as a gift to Coast Guard.

19 (B) The United States shall have no re-  
20 sponsibility for project management.

21 (C) The Association shall be responsible  
22 for preparation of the design and plans for fa-  
23 cilities constructed under the license, except  
24 that the design and plans shall be subject to the  
25 approval of the Commandant

1           (3) FUNDING.—(A) The Commandant shall not  
2       allow construction of facilities for the Museum to  
3       begin, and may not provide any Federal funds for  
4       that construction, unless the Commandant deter-  
5       mines that sufficient amounts, not less than  
6       \$10,000,000, are available from non-Federal sources  
7       to complete construction of the Museum in accord-  
8       ance with the design and plans approved under  
9       paragraph (2)(C).

10          (B) For the purposes of constructing the Mu-  
11       seum, and subject to the availability of appropria-  
12       tions, the Commandant may transfer to the Associa-  
13       tion up to \$10,000,000.

14          (C) The Commandant shall require that  
15       amounts transferred under subparagraph (B) that  
16       are not expended on the construction of the Museum  
17       shall be returned to the Coast Guard and deposited  
18       into the Fund.

19          (4) LIABILITY.—The United States shall not be  
20       liable for any act or omission relating to construc-  
21       tion under the license.

22          (c)     COMMANDANT’S     AUTHORITIES.—Notwith-  
23       standing any other provision of law, in connection with  
24       the establishment, operation, and maintenance of the Mu-  
25       seum, the Commandant may—

1           (1) rent or lease space within the Museum for  
2           gift shops, food concessions, meeting or special event  
3           spaces, and similar purposes or activities, under  
4           such terms and conditions, and for such periods of  
5           time, as the Commandant considers appropriate;

6           (2) accept, hold, administer, and, without fur-  
7           ther Act of appropriation, spend any gift, devise, or  
8           bequest of real or personal property (including  
9           funds) that is made on the condition that it be used  
10          for the benefit of, or in connection with the estab-  
11          lishment, operation, or maintenance of, the Museum;

12          (3) pay necessary expenses in connection with  
13          the conveyance or transfer of any such gift, devise  
14          or bequest; and

15          (4) perform other acts as the Commandant  
16          deems reasonable and appropriate.

17          (d) TREATMENT OF GIFTS.—For the purposes of  
18          Federal income, estate, and gift taxes, property that is ac-  
19          cepted under subsection (c)(2) shall be considered as a  
20          gift, devise, or bequest to or for the use of the United  
21          States.

22      **SEC. 5. NATIONAL COAST GUARD MUSEUM FUND.**

23          (a) ESTABLISHMENT.—There is established in the  
24          Treasury a separate account that shall be known as the  
25          “National Coast Guard Museum Fund”.

1 (b) CONTENTS.—The Fund shall consist of the fol-  
2 lowing:

3 (1) Gifts, devises, and bequests of funds accept-  
4 ed under section 4(c)(2).

5 (2) Amounts received by the United States  
6 from the rental or leasing of space within the Mu-  
7 seum under section 4(a).

8 (3) Interest credited under subsection (d).

9 (4) Amounts deposited under section  
10 4(b)(3)(C).

11 (c) USE.—The Commandant may make disburse-  
12 ments from the Fund for the establishment, operation, or  
13 maintenance of the Museum, without further Act of appro-  
14 priation and without fiscal year limitation.

15 (d) INVESTMENT.—

16 (1) IN GENERAL.—Upon request of the Com-  
17 mandant, the Secretary of the Treasury may invest  
18 amounts in the Fund in securities of, or in securities  
19 whose principal and interest are guaranteed by, the  
20 United States Government.

21 (2) INTEREST.—The interest and profits accru-  
22 ing from investments under this subsection shall be  
23 deposited to the credit of the Fund.
