A BILL

To provide a biennial budget for the United States
Government.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Commission on Federal*
5 *Budget Concepts Act of 2001”.*

6 **SEC. 2. FINDINGS AND PURPOSE.**

7 *(a) FINDINGS.—Congress finds that—*

8 *(1) President Lyndon Johnson created the Com-*
9 *mission on Federal Budget Concepts in 1967 by exec-*
10 *utive order to assess the basic budget concepts that*
11 *underlie the Federal budget process;*

12 *(2) the Commission’s report provided a common*
13 *framework for the development, presentation, and exe-*
14 *cution of the Federal budget for the ensuing decades;*

15 *(3) since the release of that report, the Federal*
16 *Government has experienced major changes in the*
17 *scope of its financial commitments, the nature of its*
18 *various budget transactions, the role of Congress in*

1 *budget decisions, and the imposition of special con-*
 2 *trols over spending and revenue; and*

3 *(4) in view of these changes, a new Commission*
 4 *on Federal Budget Concepts should be created to as-*
 5 *sess the present state of budget concepts and forge a*
 6 *bipartisan consensus for necessary changes.*

7 *(b) PURPOSE.—The purpose of this Act is to establish*
 8 *the Commission on Federal Budget Concepts to review,*
 9 *evaluate, and make recommendations respecting the budget*
 10 *concepts that underlie the Federal budget and the Federal*
 11 *budget process and to assess the feasibility of changing from*
 12 *an annual to a biennial budget cycle.*

13 **SEC. 3. ESTABLISHMENT OF COMMISSION ON FEDERAL**
 14 **BUDGET CONCEPTS.**

15 *There is established a commission to be known as the*
 16 *Commission on Federal Budget Concepts (hereinafter re-*
 17 *ferred to as the “Commission”).*

18 **SEC. 4. POWERS AND DUTIES OF COMMISSION.**

19 *(a) DUTIES OF THE COMMISSION.—*

20 *(1) The duties of the Commission shall include—*

21 *(A) an identification of activities, entities,*
 22 *and transactions to be included in the Federal*
 23 *budget and the criteria for making such deter-*
 24 *minations;*

1 (B) an assessment of the appropriate meas-
2 ures of Federal financial commitments to allo-
3 cate resources and establish fiscal policy;

4 (C) an evaluation of the differences between
5 user fees and revenue, and between various forms
6 of user fees, and the circumstances when such
7 fees should be accounted for as offsetting spend-
8 ing or adding to revenue;

9 (D) an appraisal of the appropriate usage
10 of cash and accrual-based measures for various
11 types of Federal financial commitments, such as
12 Government insurance, loan guarantees, and
13 leasing;

14 (E) recommendations of the appropriate
15 means for recognizing the cost of acquisition and
16 disposition of various types of nonfinancial as-
17 sets;

18 (F) an evaluation of appropriate measures
19 of Federal debt, borrowing, and means of financ-
20 ing;

21 (G) an assessment of the adequacy of the
22 current account and fund structure for recording
23 revenue and expenditures for specific classes of
24 governmental activities;

1 (H) recommendations for changes in Fed-
2 eral budget practices to accommodate the Federal
3 Accounting Standards Advisory Board's rec-
4 ommended accounting standards;

5 (I) recommendations for changes in budget
6 practices to reflect the Federal Government's
7 multi-year acquisitions;

8 (J) the appropriate means of accounting for
9 the financial risk the Federal Government incurs
10 from contractual and implied commitments; and

11 (K) an assessment of the value and feasi-
12 bility of changing the Federal budget cycle from
13 annual to biennial.

14 (2) *EXCEPTIONS.*—Notwithstanding paragraph
15 (1), the Commission shall make no findings, conclu-
16 sions, or recommendations respecting the following:

17 (A) Social security and medicare.

18 (B) Budget estimates and projections that
19 assume that selected tax policies will increase
20 gross domestic product and thereby cause an in-
21 direct increase in revenue, or that assume that
22 increased spending for human resources or cap-
23 ital development will cause an indirect reduction
24 in spending for other programs.

25 (C) Government-sponsored enterprises.

1 (b) *POWERS OF THE COMMISSION.*—

2 (1) *CONDUCT OF BUSINESS.*—*The Commission*
3 *may hold hearings, take testimony, receive evidence,*
4 *and undertake such other activities necessary to carry*
5 *out its duties.*

6 (2) *ACCESS TO INFORMATION.*—*The Commission*
7 *may secure directly from any department of agency*
8 *of the United States information necessary to carry*
9 *out its duties. Upon request of the Chair of the Com-*
10 *mission, the head of that department or agency shall*
11 *furnish that information to the Commission.*

12 (3) *POSTAL SERVICE.*—*The Commission may use*
13 *the United States mails in the same manner and*
14 *under the same conditions as other departments and*
15 *agencies of the United States.*

16 **SEC. 5. MEMBERSHIP.**

17 (a) *MEMBERSHIP.*—*The Commission shall be com-*
18 *posed of 14 voting members and 2 nonvoting members, as*
19 *follows:*

20 (1) *Three members appointed by the chairman of*
21 *the Committee on the Budget of the Senate.*

22 (2) *Three members appointed by the chairman of*
23 *the Committee on the Budget of the House of Rep-*
24 *resentatives.*

1 (3) *Three members appointed by the ranking*
 2 *member of the Committee on the Budget of the Senate.*

3 (4) *Three members appointed by the ranking*
 4 *member of the Committee on the Budget of the House*
 5 *of Representatives.*

6 (5) *The Director of the Office of Management*
 7 *and Budget (or his designee).*

8 (6) *The Secretary of the Treasury (or his des-*
 9 *ignee).*

10 (7) *The Comptroller General of the United States*
 11 *(or his designee) and the Director of the Congressional*
 12 *Budget Office (or his designee), who shall be non-*
 13 *voting members.*

14 (b) *QUALIFICATIONS AND TERM.—*

15 (1) *QUALIFICATIONS.—Members appointed to the*
 16 *Commission pursuant to subsection (a) shall—*

17 (A) *have expertise and experience in the*
 18 *fields or disciplines related to the subject areas to*
 19 *be considered by the Commission; and*

20 (B) *not be Members of Congress.*

21 (2) *TERM OF APPOINTMENT.—The term of an*
 22 *appointment to the Commission shall be for the life*
 23 *of the Commission.*

24 (3) *CHAIR AND VICE CHAIR.—The member of the*
 25 *Commission serving under subsection (a)(5) shall be*

1 *the Chair of the Commission. A Vice Chair may be*
2 *elected from among the voting members of the Com-*
3 *mission and shall assume the duties of the Chair in*
4 *the Chair's absence.*

5 *(c) MEETINGS; QUORUM; AND VACANCIES.—*

6 *(1) MEETINGS.—The Commission shall meet at*
7 *least once a month on a day to be decided by the*
8 *Commission. The Commission may meet at such other*
9 *times at the call of the Chair or of a majority of its*
10 *voting members. The meetings of the Commission*
11 *shall be open to the public, unless by public vote, the*
12 *Commission shall determine to close a meeting or any*
13 *portion of a meeting to the public.*

14 *(2) QUORUM.—A majority of the voting member-*
15 *ship shall constitute a quorum of the Commission, ex-*
16 *cept that 3 or more voting members may conduct*
17 *hearings.*

18 *(3) VACANCIES.—A vacancy on the Commission*
19 *shall be filled in the same manner in which the origi-*
20 *nal appointment was filled under subsection (a).*

21 *(d) COMPENSATION AND EXPENSES.—Members of the*
22 *Commission shall serve without pay for their service on the*
23 *Commission, but may receive travel expenses, including per*
24 *diem in lieu of subsistence, at rates authorized for employ-*

ees of agencies under subchapter I of chapter 57 of title 5,
United States Code.

SEC. 6. STAFF AND SUPPORT SERVICES.

(a) *STAFF*.—With the advance approval of the Commission, the executive director may appoint such personnel as is appropriate. The staff of the Commission shall be appointed without regard to political affiliation and without regard to the provisions of title 5, United States Code, governing appointments in the competitive service, and may be paid without regard to the provisions of chapter 51 and subchapter III of chapter 53 of such title relating to classifications and General Schedule pay rates.

(b) *EXECUTIVE DIRECTOR*.—The Chairman shall appoint an executive director, who shall be paid the rate of basic pay for level II of the Executive Schedule.

(c) *EXPERTS AND CONSULTANTS*.—With the advance approval of the Commission, the executive director may procure temporary and intermittent services under section 3109(b) of title 5, United States Code.

(d) *TECHNICAL AND ADMINISTRATIVE ASSISTANCE*.—Upon the request of the Commission—

(1) the head of any agency, office, or establishment within the executive or legislative branches of the United States shall provide, without reimburse-

1 *ment, such technical assistance as the Commission de-*
2 *termines is necessary to carry out its duties; and*

3 *(2) the Administrator of the General Services*
4 *Administration shall provide, on a reimbursable*
5 *basis, such administrative support services as the*
6 *Commission may require.*

7 *(e) DETAIL OF FEDERAL PERSONNEL.—Upon the re-*
8 *quest of the Commission, the head of an agency, office, or*
9 *establishment in the executive or legislative branch of the*
10 *United States is authorized to detail, without reimburse-*
11 *ment, any of the personnel of that agency, office, or estab-*
12 *lishment to the Commission to assist the Commission in*
13 *carrying out its duties. Any such detail shall not interrupt*
14 *or otherwise affect the employment status or privileges of*
15 *that employee.*

16 *(f) CBO.—The Director of the Congressional Budget*
17 *Office shall provide the Commission with its latest research*
18 *on the accuracy of its past budget and economic projections*
19 *as compared to those of the Office of Management and*
20 *Budget and, if possible, those of private sector forecasters.*
21 *The Commission shall work with the Directors of the Con-*
22 *gressional Budget Office and the Office of Management and*
23 *Budget in their efforts to explain the factors affecting the*
24 *accuracy of budget projections.*

1 **SEC. 7. REPORT.**

2 *Not later than November 15, 2002, the Commission*
3 *shall transmit a report to the President and to each House*
4 *of Congress. The report shall contain a detailed statement*
5 *of the findings and conclusions of the Commission, together*
6 *with its recommendations for such legislative or adminis-*
7 *trative actions as it considers appropriate. No finding, con-*
8 *clusion, or recommendation may be made by the Commis-*
9 *sion unless approved by a majority of those voting (includ-*
10 *ing in such majority at least two members serving under*
11 *paragraph (2), (3), (5), or (6) of section 5(a) and at least*
12 *two members serving under paragraph (1) or (4) of such*
13 *section), a quorum being present. At the request of any*
14 *Commission member, the report shall include that member's*
15 *dissenting findings, conclusions, or recommendations.*

16 **SEC. 8. TERMINATION.**

17 *The Commission shall terminate 30 days after the date*
18 *of transmission of the report required in section 7.*

19 **SEC. 9. FUNDING.**

20 *There are authorized to be appropriated not more than*
21 *\$1,000,000 to carry out this Act. Sums so appropriated*
22 *shall remain available until expended.*

Amend the title so as to read: “A bill to establish
the Commission on Federal Budget Concepts.”.

1 SECTION 1. SHORT TITLE; FINDINGS.

2 (a) **SHORT TITLE.**—This Act may be cited as
3 the “Budget Responsibility and Efficiency Act
4 of 2001”.

5 (b) **FINDINGS.**—The Congress finds that—

6 (1) the annual appropriations and
7 budget process increasingly dominates
8 the congressional agenda and Congress
9 regularly fails to meet the deadlines of
10 the Congressional Budget Act of 1974;

11 (2) the design of the budget process
12 has led to repetitive and time-consuming
13 budget votes, decreasing the time avail-
14 able for the systematic and programmatic
15 oversight of Federal programs and delay-
16 ing the enactment of legislation nec-
17 essary to fund the Government;

18 (3) Congress’ responsibility to im-
19 prove the efficiency, economy, and effec-
20 tiveness of governmental operations,
21 evaluate programs and performance, de-
22 tect and prevent poor administration,
23 waste, or abuse in Government programs,
24 ensure that executive policies reflect the
25 public interest, ensure administrative
26 compliance with legislative intent, and

1 **prevent executive encroachment on legis-**
2 **lative authority and prerogatives is un-**
3 **dermined by the current time-consuming**
4 **and repetitive budget process;**

5 **(4) an annual budget process encour-**
6 **ages inefficiency in the management, sta-**
7 **bility, and predictability of Federal fund-**
8 **ing, particularly for States and localities;**

9 **(5) a biennial budget process will re-**
10 **duce the number of budget-related votes**
11 **during each Congress, enhance congres-**
12 **sional oversight of Government oper-**
13 **ations, encourage longer time horizons in**
14 **policy planning and greater stability in**
15 **fiscal policy;**

16 **(6) a biennial budget process was a**
17 **principal recommendation of the 1993**
18 **Joint Committee on the Organization of**
19 **Congress and the Vice President's Na-**
20 **tional Performance Review;**

21 **(7) since the enactment of the Con-**
22 **gressional Budget Act of 1974, more than**
23 **50 bills addressing a two-year budget**
24 **cycle have been introduced, 10 biennial**
25 **budget related provisions were reported**

1 by congressional committees, 7 passed ei-
2 ther chamber and 4 were enacted; more
3 than 40 congressional or special com-
4 mittee hearings addressed the issue of bi-
5 ennial budgeting; and the Congressional
6 Budget Office, the Office of Management
7 and Budget, and 5 different special task
8 forces or joint committees of Congress
9 have either recommended biennial budg-
10 eting or further studies of it;

11 (8) the adoption of a biennial budget
12 process was recommended by President
13 Reagan in the fiscal year 1989 budget
14 submission, by President Bush in the fis-
15 cal years 1990 and 1991 budget submis-
16 sions, by President Clinton in the fiscal
17 years 1995, 2000, and 2001 budget submis-
18 sions, and by President Bush in the fiscal
19 year 2002 budget submission; and

20 (9) a bipartisan majority of Members
21 of the House of Representatives support
22 a biennial budget process.

1 SEC. 2. REVISION OF TIMETABLE.

2 Section 300 of the Congressional Budget
3 Act of 1974 (2 U.S.C. 631) is amended to read
4 as follows:

5 "TIMETABLE

6 "SEC. 300. (a) IN GENERAL.—Except as pro-
7 vided by subsection (b), the timetable with re-
8 spect to the congressional budget process for
9 any Congress (beginning with the One Hun-
10 dred Ninth Congress) is as follows:

1 “(b) SPECIAL RULE.—In the case of any first
2 session of Congress that begins in any year
3 during which the term of a President (except
4 a President who succeeds himself) begins, the

6 in subsection (a):

First Monday in April	President submits budget recommendations.

7 SEC. 3. AMENDMENTS TO THE CONGRESSIONAL BUDGET
8 AND IMPOUNDMENT CONTROL ACT OF 1974.

9 (a) DECLARATION OF PURPOSE.—Section
10 2(2) of the Congressional Budget and Im-
11 poundment Control Act of 1974 (2 U.S.C.
12 621(2)) is amended by striking “each year”
13 and inserting “biennially”.

1 **(b) DEFINITIONS.—**

2 **(1) BUDGET RESOLUTION.—**Section 3(4)
 3 **of such Act (2 U.S.C. 622(4)) is amended**
 4 **by striking “fiscal year” each place it ap-**
 5 **pears and inserting “biennium”.**

6 **(2) BIENNIUM.—**Section 3 of such Act
 7 **(2 U.S.C. 622) ~~(as amended by section 3)~~ is**
 8 **further amended by adding at the end**
 9 **the following new paragraph:**

10 **“~~(13)~~ (11) term ‘biennium’ means the**
 11 **period of 2 consecutive fiscal years begin-**
 12 **ning on October 1 of any odd-numbered**
 13 **year.”.**

14 **(c) BIENNIAL CONCURRENT RESOLUTION ON**
 15 **THE BUDGET.—**

16 **(1) CONTENTS OF RESOLUTION.—**Section
 17 **301(a) of such Act (2 U.S.C. 632(a)) is**
 18 **amended—**

19 **(A) in the matter preceding para-**
 20 **graph (1) by—**

21 **(i) striking “April 15 of each**
 22 **year” and inserting “May 15 of**
 23 **each odd-numbered year”;**

24 **(ii) striking “the fiscal year**
 25 **beginning on October 1 of such**

1 year” the first place it appears
2 and inserting “the biennium be-
3 ginning on October 1 of such
4 year”; and

5 (iii) striking “the fiscal year
6 beginning on October 1 of such
7 year” the second place it appears
8 and inserting “each fiscal year in
9 such period”;

10 (B) in paragraph (6), by striking
11 “for the fiscal year” and inserting “for
12 each fiscal year in the biennium”; and

13 (C) in paragraph (7), by striking
14 “for the fiscal year” and inserting “for
15 each fiscal year in the biennium”.

16 (2) ADDITIONAL MATTERS.—Section
17 301(b) of such Act (2 U.S.C. 632(b)) is
18 amended—

19 (A) in paragraph (3), by striking
20 “for such fiscal year” and inserting
21 “for either fiscal year in such bien-
22 nium”; and

23 (B) in paragraph (7), by striking
24 “for the first fiscal year” and insert-

1 ing “for each fiscal year in the bien-
2 nium”.

3 (3) VIEWS OF OTHER COMMITTEES.—Sec-
4 tion 301(d) of such Act (2 U.S.C. 632(d)) is
5 amended by inserting “(or, if applicable,
6 as provided by section 300(b))” after
7 “United States Code”.

8 (4) HEARINGS.—Section 301(e)(1) of
9 such Act (2 U.S.C. 632(e)) is amended by—

10 (A) striking “fiscal year” and in-
11 serting “biennium”; and

2 program authorizations to a multi-year sched-
3 ule.

4 (2) During the 108th Congress, the Comp-
5 troller General of the United States will con-
6 tinue to provide assistance to the Congress
7 with respect to programmatic oversight and
8 in particular will assist the committees of
9 Congress in designing and conforming pro-

6 ommendations regarding, the transitional bi-
7 ennial budget process for the fiscal year 2004–
8 2005 biennium that was carried out pursuant
9 to this section.

10 **(g) CBO TRANSITIONAL REPORT.**—On or be-
11 fore March 31, 2004, the Director of the Con-
12 gressional Budget Office shall submit to Con-
13 gress an evaluation of, and recommendations
14 regarding, the transitional biennial budget
15 process for the fiscal year 2004–2005 biennium
16 that was carried out pursuant to this section.

17 **SEC. 13. EFFECTIVE DATE.**

18 **Except as provided by sections 8, 11, and**
19 **12, this Act and the amendments made by it**
20 **shall take effect on January 1, 2005, and shall**
21 **apply to budget resolutions and appropria-**
22 **tions for the biennium beginning with fiscal**
23 **year 2006.**
