Mr. McCONNELL introduced the following bill; which was read twice and
referred to the Committee on the Judiciary

A BILL

To provide for the effective punishment of online child
molesters, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cybermolesters En-
5 forcement Act of 2001”.

6 **SEC. 2. MANDATORY MINIMUM SENTENCES.**

7 Section 2423 of title 18, United States Code, is
8 amended—

9 (1) in subsection (b), by inserting “not less
10 than 5 and” before “not more than 15”; and

1 (2) in subsection (c), by inserting “not less
2 than 5 and” before “not more than 15”.

3 **SEC. 3. AUTHORIZATION OF INTERCEPTION OF COMMU-**
4 **NICATIONS IN THE INVESTIGATION OF SEX-**
5 **UAL CRIMES AGAINST CHILDREN.**

6 (a) CHILD PORNOGRAPHY.—Section 2516(1)(c) of
7 title 18, United States Code, is amended by inserting “sec-
8 tion 2252A (relating to material constituting or containing
9 child pornography),” after “2252 (sexual exploitation of
10 children),”.

11 (b) TRANSPORTATION FOR ILLEGAL SEXUAL ACTIV-
12 ITY.—Section 2516(1) of title 18, United States Code, as
13 amended by section 3 of this Act, is amended—

14 (1) by striking “or” at the end of paragraph
15 (o);

16 (2) by inserting after paragraph (o) the fol-
17 lowing:

18 “(p) a violation of section 2422 (relating to
19 coercion and enticement) or section 2423 (relat-
20 ing to transportation of minors) of this title, if,
21 in connection with that violation, the sexual ac-
22 tivity for which a person may be charged with
23 a criminal offense would constitute a felony of-
24 fense under chapter 109A or 110, if that activ-
25 ity took place within the special maritime and

1 territorial jurisdiction of the United States; or”;

2 and

3 (3) by redesignating paragraph (p) as para-
4 graph (q).

5 (c) TECHNICAL AMENDMENT ELIMINATING DUPLI-
6 CATIVE PROVISION.—Section 2516(1) of title 18, United
7 States Code, is amended—

8 (1) by striking the first paragraph (p); and

9 (2) by inserting “or” at the end of paragraph
10 (o).

11 **SEC. 4. CHILD PORNOGRAPHY AS CONTRABAND.**

12 Section 80302(a) of title 49, United States Code, is
13 amended—

14 (1) in paragraph (5), by striking “or” after the
15 semicolon;

16 (2) in paragraph (6)(D), by striking the period
17 and inserting “; or”; and

18 (3) by inserting at the end the following:

19 “(7) material involved in a violation of section
20 2252A of title 18, United States Code (relating to
21 material constituting or containing child pornog-
22 raphy).”.
