A BILL

To amend the Central Utah Project Completion Act to clarify the responsibilities of the Secretary of the Interior with respect to the Central Utah Project, to redirect unexpended budget authority for the Central Utah Project for wastewater treatment and reuse and other purposes, to provide for prepayment of repayment contracts for municipal and industrial water delivery facilities, and to eliminate a deadline for such prepayment.

1 **SECTION 1. AMENDMENTS TO THE CENTRAL UTAH**
 2 **PROJECT COMPLETION ACT.**

3 (a) CLARIFICATION OF SECRETARIAL RESPONSIBIL-
 4 ITIES.—Section 201(e) of the Central Utah Project Com-
 5 pletion Act (Public Law 102–575; 106 Stat. 4608) is
 6 amended—

7 (1) by striking “identified in this Act,” and in-
 8 serting “identified in this title and the Act of April
 9 11, 1956 (70 Stat. 105; chapter 203) (commonly
 10 known as the ‘Colorado River Storage Project Act’),
 11 relating to the Central Utah Project (including over-
 12 sight for all phases of the Central Utah Project, the
 13 administration of all prior and future contracts, and
 14 operation and maintenance of previously constructed
 15 facilities),”; and

16 (2) by striking “his responsibilities under this
 17 Act” and inserting “those responsibilities”.

18 (b) USE OF UNEXPENDED BUDGET AUTHORITY.—
 19 Section 202(c) of the Central Utah Project Completion
 20 Act (106 Stat. 4611; 113 Stat. 1698) is amended in the
 21 first sentence—

22 (1) by striking “in this title up to \$60,000,000”
 23 and inserting “for units of the Central Utah
 24 Project”; and

1 (2) by inserting “(including use of reverse os-
2 mosis membrane technologies, water recycling, and
3 conjunctive use)” after “conservation measures”.

4 (c) PREPAYMENT OF REPAYMENT.—Section 210 of
5 the Central Utah Project Completion Act (106 Stat. 4624;
6 110 Stat. 3387) is amended—

7 (1) in the second sentence—

8 (A) by inserting “or any additional or sup-
9 plemental repayment contract” after “1985,”;
10 and

11 (B) by inserting “of the Central Utah
12 Project” after “water delivery facilities”; and

13 (2) by striking the fourth sentence.
