A BILL

To amend title XVIII of the Social Security Act to provide appropriate reimbursement under the medicare program for ambulance trips originating in rural areas.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare Rural Ambu-
- 5 lance Relief Act of 2001".
- 6 SEC. 2. HOLD HARMLESS PROVISION FOR RURAL AMBU-
- 7 LANCE SERVICES.
- 8 (a) IN GENERAL.—Section 1834(l) of the Social Se-
- 9 curity Act (42 U.S.C. 1395m(l)) is amended—

1	(1) in paragraph (2)(A), by inserting "(other
2	than increases required by paragraph (10))" after
3	"part";
4	(2) in paragraph (3)(A), by inserting "and if
5	the services for which payment is made under para-
6	graph (10) were paid under such fee schedule" after
7	"in effect";
8	(3) by redesignating paragraph (8), as added by
9	section 221(a) of the Medicare, Medicaid, and
10	SCHIP Benefits Improvement and Protection Act of
11	2000 (114 Stat. 2763A-486), as enacted into law by
12	section 1(a)(6) of Public Law 106–554, as para-
13	graph (9); and
14	(4) by adding at the end the following new
15	paragraph:
16	"(10) Hold Harmless Provision for Rural
17	AMBULANCE SERVICES.—
18	"(A) In General.—Notwithstanding the
19	fee schedule established under paragraph (1), in
20	the case of ambulance services furnished on or
21	after the date on which the phase-in required
22	under paragraph (2)(E) is initially implemented
23	and before the date on which the fee schedule
24	established under this subsection is modified to

incorporate the adjustments authorized under

1	section 221(c) of the Medicare, Medicaid, and
2	SCHIP Benefits Improvement and Protection
3	Act of 2000 (or the date on which the Secretary
4	determines that such a modification is unneces-
5	sary), for which the transportation originates in
6	a rural area (as defined in section
7	1886(d)(2)(D)) or in a rural census tract of a
8	metropolitan statistical area (as determined
9	under the most recent modification of the Gold-
10	smith Modification, originally published in the
11	Federal Register on February 27, 1992 (57
12	Fed. Reg. 6725)), the amount of payment
13	under this subsection for such services shall be
14	the greater of—
15	"(i) the amount determined under the
16	fee schedule established under paragraph
17	(1) (without regard to any phase-in estab-
18	lished under paragraph $(2)(E)$; or
19	"(ii) the amount that would have been
20	paid for such service if the amendments
21	made by section 4531(b) of the Balanced
22	Budget Act of 1997 had not been enacted.
23	"(B) Prohibiting Certain Reduc-
24	TIONS.—Notwithstanding paragraph (3), the
25	Secretary shall not reduce the payment

1	amounts under the fee schedule established
2	under paragraph (1) to offset the increase in
3	payments resulting from the application of sub-
4	paragraph (A).".
5	(b) Conforming Amendment.—Section
6	1833(a)(1)(R)(i) of the Social Security Act (42 U.S.C.
7	1395l(a)(1)(R)(i)) is amended by inserting "(or, in the
8	case of ambulance services to which paragraph (10) of
9	such section applies, 80 percent of the lesser of the actual
10	charge for such service or the amount determined under
11	such paragraph)" after "1834(l)".
