To amend title 10, United States Code, to improve the organization and management of the Department of Defense with respect to space programs and activities, and for other purposes.

Mr. Allard (for himself and Mr. Smith of New Hampshire) introduced the following bill; which was read twice and referred to the Committee on Armed Services

## A BILL

- To amend title 10, United States Code, to improve the organization and management of the Department of Defense with respect to space programs and activities, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. ESTABLISHMENT OF POSITION OF UNDER SEC-
  - 4 RETARY OF DEFENSE FOR SPACE, INTEL-
  - 5 LIGENCE, AND INFORMATION.
  - 6 (a) Authority of Secretary of Defense To Es-
  - 7 TABLISH POSITION.—Upon the direction of the President,
  - 8 the Secretary of Defense may, subject to subsection (b),

establish in the Office of the Secretary of Defense the po-2 sition of Under Secretary of Defense for Space, Intel-3 ligence, and Information. If the position is so established, 4 the Under Secretary of Defense for Space, Intelligence, 5 and Information shall perform duties and exercise powers as set forth under section 137 of title 10, United States 6 Code, as amended by subsection (d). 8 (b) DEADLINE FOR EXERCISE OF AUTHORITY.—The Secretary may not exercise the authority in subsection (a) 10 after December 31, 2003. 11 (c) Notice of Exercise of Authority.—If the 12 authority in subsection (a) is exercised, the Secretary shall immediately notify Congress of the establishment of the position of Under Secretary of Defense for Space, Intelligence, and Information, together with the date on which the position is established. 16 17 (d) Nature of Position.— 18 (1) IN GENERAL.—Effective as of the date pro-19 vided for in paragraph (7), chapter 4 of title 10, 20 United States Code, is amended— 21 (A) by redesignating section 137 as section 22 139a and by transferring such section (as so re-23 designated) within such chapter so as to appear 24 after section 139; and

1	(B) by inserting after section 136 the fol-
2	lowing new section 137:
3	"§ 137. Under Secretary of Defense for Space, Intel-
4	ligence, and Information
5	"(a) There is an Under Secretary of Defense for
6	Space, Intelligence, and Information, appointed from civil-
7	ian life by the President, by and with the advice and con-
8	sent of the Senate.
9	"(b) Subject to the authority, direction, and control
10	of the Secretary of Defense, the Under Secretary of De-
11	fense for Space, Intelligence, and Information shall per-
12	form such duties and exercise such powers relating to the
13	space, intelligence, and information programs and activi-
14	ties of the Department of Defense as the Secretary of De-
15	fense may prescribe. The duties and powers prescribed for
16	the Under Secretary shall include the following:
17	"(1) In coordination with the Under Secretary
18	of Defense for Policy, the establishment of policy on
19	space.
20	"(2) In coordination with the Under Secretary
21	of Defense for Acquisition, Technology, and Logis-
22	tics, the acquisition of space systems.
23	"(3) The deployment and use of space assets.

1	"(4) The oversight of research, development,
2	acquisition, launch, and operation of space, intel-
3	ligence, and information assets.
4	"(5) The coordination of military intelligence
5	activities within the Department.
6	"(6) The coordination of intelligence activities
7	of the Department and the intelligence community
8	in order to meet the long-term intelligence require-
9	ments of the United States.
10	"(7) The coordination of space activities of the
11	Department with commercial and civilian space ac-
12	tivities.
13	"(c) The Secretary of Defense shall designate the
14	Under Secretary of Defense for Space, Intelligence, and
15	Information as the Chief Information Officer of the De-
16	partment of Defense under section 3506(a)(2)(B) of title
17	44.
18	"(d) The Under Secretary of Defense for Space, In-
19	telligence, and Information takes precedence in the De-
20	partment of Defense after the Under Secretary of Defense
21	for Personnel and Readiness.".
22	(2) Additional assistant secretary of de-
23	FENSE.—Section 138(a) of that title is amended by
24	striking "nine Assistant Secretaries of Defense" and

inserting "ten Assistant Secretaries of Defense".

1	(3) Duties of assistant secretaries of
2	DEFENSE FOR SPACE, INTELLIGENCE, AND INFOR-
3	MATION.—Section 138(b) of that title is amended by
4	adding at the end the following new paragraph:
5	"(7) Two of the Assistant Secretaries shall have as
6	their principal duties supervision of activities relating to
7	space, intelligence, and information. The Assistant Secre-
8	taries shall each report to the Under Secretary of Defense
9	for Space, Intelligence, and Information in the perform-
10	ance of such duties.".
11	(4) Conforming Amendments.—Section
12	131(b) of that title is amended—
13	(A) by redesignating paragraphs (6)
14	through (11) as paragraphs (7) through (12),
15	respectively; and
16	(B) by inserting after paragraph (5) the
17	following new paragraph (6):
18	"(6) The Under Secretary of Defense for
19	Space, Intelligence, and Information.".
20	(5) Pay Levels.—(A) Section 5314 of title 5,
21	United States Code, is amended by inserting after
22	"Under Secretary of Defense for Personnel and
23	Readiness" the following:
24	"Under Secretary of Defense for Space, Intel-
25	ligence, and Information.".

1	(B) Section 5315 of title 5, United States Code,
2	is amended in the item relating to Assistant Secre-
3	taries of Defense by striking "(9)" and inserting
4	"(10)".
5	(6) CLERICAL AMENDMENTS.—The table of sec-
6	tions at the beginning of chapter 4 of title 10,
7	United States Code, is amended—
8	(A) by striking the item relating to section
9	137 and inserting the following new item:
	"137. Under Secretary of Defense for Space, Intelligence, and Information."; and
10	(B) by inserting after the item relating to
11	section 139 the following new item:
	"139a. Director of Defense Research and Engineering.".
12	(7) Effective date.—The amendments made
13	by this subsection shall take effect as of the date
14	specified in the notification provided by the Sec-
15	retary of Defense to Congress under subsection (c)
16	of the exercise of the authority in subsection (a).
17	(e) Report.—(1) Not later than 30 days before an
18	exercise of the authority provided in subsection (a), the
19	President shall submit to Congress a report on the pro-
20	posed organization of the office of the Under Secretary
21	of Defense for Space, Intelligence, and Information.
22	(2) If the Secretary of Defense has not exercised the
23	authority granted in subsection (a) on the date that is one

- 2 retary shall submit to the Committees on Armed Services
- 3 of the Senate and the House of Representatives on that
- 4 date a report describing the actions taken by the Secretary

- 12 SEC. 2. RESPONSIBILITY FOR SPACE PROGRAMS.
- 13 (a) In General.—Part IV of subtitle A of title 10,
- 14 United States Code, is amended by inserting after chapter
- 15 134 the following new chapter:

### 16 **"CHAPTER 135—SPACE PROGRAMS**

### 17 "§ 2271. Responsibility for space programs

- 18 "(a) Responsibility of Secretary of Air Force
- 19 AS EXECUTIVE AGENT.—The Secretary of the Air Force
- 20 shall be the executive agent of the Department of Defense
- 21 for functions of the Department designated by the Sec-
- 22 retary of Defense with respect to the following:

- 1 "(1) Planning for the acquisition programs,
- 2 projects, and activities of the Department that relate
- 3 to space.
- 4 "(2) Efficient execution of the programs,
- 5 projects, and activities.
- 6 "(b) Responsibility of Under Secretary of Air
- 7 Force as Acquisition Executive.—The Under Sec-
- 8 retary of the Air Force shall be the acquisition executive
- 9 of the Department of the Air Force for the programs,
- 10 projects, and activities referred to in subsection (a).
- 11 "(c) Responsibility of Under Secretary of Air
- 12 Force as Director of NRO.—The Under Secretary of
- 13 the Air Force shall act as the Director of the National
- 14 Reconnaissance Office.
- 15 "(d) Coordination of Duties of Under Sec-
- 16 RETARY OF AIR FORCE.—In carrying out duties under
- 17 subsections (b) and (c), the Under Secretary of the Air
- 18 Force shall coordinate the space programs, projects, and
- 19 activities of the Department of Defense and the programs,
- 20 projects, and activities of the National Reconnaissance Of-
- 21 fice.
- 22 "(e) Space Career Field.—(1) The Under Sec-
- 23 retary of the Air Force shall establish and implement poli-
- 24 cies and procedures to develop a cadre of technically com-
- 25 petent officers with the capability to develop space doc-

1	trine, concepts of space operations, and space systems for
2	the Department of the Air Force.
3	"(2) The Secretary of the Air Force shall assign to
4	the commander of Air Force Space Command primary re-
5	sponsibility for—
6	"(A) establishing and implementing education
7	and training programs for space programs, projects,
8	and activities of the Department of the Air Force;
9	and
10	"(B) management of the space career field
11	under paragraph (1).
12	"(f) Joint Program Management.—The Under
13	Secretary of the Air Force shall take appropriate actions
14	to ensure that, to maximum extent practicable, Army,
15	Navy, Marine Corps, and Air Force personnel are as-
16	signed, on a joint duty assignment basis, as follows:
17	"(1) To carry out the space development and
18	acquisition programs of the Department of Defense;
19	and
20	"(2) To the Office of the National Security
21	Space Architect.".
22	(b) CLERICAL AMENDMENT.—The tables of chapters

4	create a major force program category for space programs

7	(b) COMMENCEMENT.—The category created under
8	subsection (a) shall be included in each future-years de-
9	fense program submitted to Congress under section 221
10	of title 10, United States Code, in fiscal years after fiscal

- 5 SEC. 5. GRADE OF COMMANDER OF AIR FORCE SPACE COM-
- 6 MAND.
- 7 (a) IN GENERAL.—Chapter 845 of title 10, United
- 8 States Code, is amended by adding at the end the fol-
- 9 lowing new section:

### 10 "§ 8584. Commander of Air Force Space Command

- 11 "(a) Grade.—The officer serving as commander of
- 12 the Air Force Space Command shall, while so serving,
- 13 have the grade of general.
- 14 "(b) Limitation on Concurrent Command As-
- 15 SIGNMENTS.—The officer serving as commander of the
- 16 Air Force Space Command may not, while so serving,
- 17 serve as commander-in-chief of the United States Space
- 18 Command (or any successor combatant command with re-
- 19 sponsibility for space) or as commander of the United

1	SEC. 6. SENSE OF CONGRESS REGARDING GRADE OF OFFI-
2	CER ASSIGNED AS COMMANDER OF UNITED
3	STATES SPACE COMMAND.
4	It is the sense of Congress that the Secretary of De-
5	fense should assign the best qualified officer of the Army,
6	Marine Corps, or Air Force with the grade of general, or
7	of the Navy with the grade of admiral, to the position of
8	Commander of the United States Space Command.
