Mr. Santorum (for himself, Mr. Rockefeller, Mrs. Lincoln, and Mr. McConnell) introduced the following bill; which was read twice and referred to the Committee on Finance

## A BILL

To amend title XVIII of the Social Security Act to provide for coverage of substitute adult day care services under the Medicare Program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare Adult Day
- 5 Services Alternative Act of 2001".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds that—
- 8 (1) adult day care offers services, including
- 9 medical care, rehabilitation therapies, dignified as-

- sistance with activities of daily living, social interaction, and stimulating activities, to seniors who are frail, physically challenged, or cognitively impaired;
  - (2) access to adult day care services provides seniors and their familial caregivers support that is critical to keeping the senior in the family home;
  - (3) more than 22,000,000 families in the United States serve as caregivers for aging or ailing seniors, nearly 1 in 4 American families, providing close to 80 percent of the care to individuals requiring long-term care;
  - (4) nearly 75 percent of those actively providing such care are women who also maintain other responsibilities, such as working outside of the home and raising young children;
  - (5) the average loss of income to these caregivers has been shown to be \$659,130 in wages, pension, and Social Security benefits;
  - (6) the loss in productivity in United States businesses ranges from \$11,000,000,000 to \$29,000,000,000 annually;
  - (7) the services offered in adult day care facilities provide continuity of care and an important sense of community for both the senior and the caregiver;

11	``(ww)(1)(A) The term 'substitute adult day care
12	services' means the items and services described in sub-
13	paragraph (B) that are furnished to an individual by an
14	adult day care facility as a part of a plan under subsection
15	(m) that substitutes such services for a portion of the
16	items and services described in subparagraph (B)(i) fur-
17	nished by a home health agency under the plan, as deter-
18	mined by the physician establishing the plan.
19	"(B) The items and services described in this sub-
20	paragraph are the following items and services:
21	"(i) Items and services described in paragraphs
22	(1) through (7) of subsection (m).
23	"(ii) Meals.
24	"(iii) A program of supervised activities de-
25	signed to promote physical and mental health and

1	furnished to the individual by the adult day care fa-
2	cility in a group setting for a period of not fewer
3	than 4 and not greater than 12 hours per day.
4	"(iv) A medication management program (as
5	defined in subparagraph (C)).
6	"(C) For purposes of subparagraph (B)(iv), the term
7	'medication management program' means a program of
8	services, including medicine screening and patient and
9	health care provider education programs, that provides
10	services to minimize—
11	"(i) unnecessary or inappropriate use of pre-
12	scription drugs; and
13	"(ii) adverse events due to unintended prescrip-
14	tion drug-to-drug interactions.
15	"(2)(A) Except as provided in subparagraphs (B)
16	and (C), the term 'adult day care facility' means a public
17	agency or private organization, or a subdivision of such
18	an agency or organization, that—
19	"(i) is engaged in providing skilled nursing
20	services and other therapeutic services directly or
21	under arrangement with a home health agency;
22	"(ii) meets such standards established by the
23	Secretary to ensure quality of care and such other
24	requirements as the Secretary finds necessary in the

- 1 interest of the health and safety of individuals who
- 2 are furnished services in the facility;
- 3 "(iii) provides the items and services described
- 4 in paragraph (1)(B); and
- 5 "(iv) meets the requirements of paragraphs (2)
- 6 through (8) of subsection (o).
- 7 "(B) Notwithstanding subparagraph (A), the term
- 8 'adult day care facility' shall include a home health agency
- 9 in which the items and services described in clauses (ii)
- 10 through (iv) of paragraph (1)(B) are provided—
- "(i) by an adult day-care program that is li-
- censed or certified by a State, or accredited, to fur-
- nish such items and services in the State; and
- "(ii) under arrangements with that program
- made by such agency.
- 16 "(C) The Secretary may waive the requirement of a
- 17 surety bond under paragraph (7) of subsection (o) in the
- 18 case of an agency or organization that provides a com-
- 19 parable surety bond under State law.
- 20 "(D) For purposes of payment for home health serv-
- 21 ices consisting of substitute adult day care services fur-
- 22 nished under this title, any reference to a home health
- 23 agency is deemed to be a reference to an adult day care
- 24 facility.".

1	(b) Payment for Substitute Adult Day Care
2	Services.—Section 1895 of the Social Security Act (42
3	U.S.C. 1395fff) is amended by adding at the end the fol-
4	lowing new subsection:
5	"(f) Payment Rate for Substitute Adult Day
6	CARE SERVICES.—In the case of home health services con-
7	sisting of substitute adult day care services (as defined
8	in section 1861(ww)), the following rules apply:
9	"(1) The Secretary shall estimate the amount
10	that would otherwise be payable under this section
11	for all home health services under that plan of care
12	other than substitute adult day care services for a
13	period specified by the Secretary.
14	"(2) The total amount payable for home health
15	services consisting of substitute adult day care serv-
16	ices under such plan may not exceed 95 percent of
17	the amount estimated to be payable under para-
18	graph (1) furnished under the plan by a home health
19	agency.".
20	(c) Adjustment in Case of Overutilization of
21	SUBSTITUTE ADULT DAY CARE SERVICES.—
22	(1) Monitoring expenditures.—Beginning
23	with fiscal year 2003, the Secretary of Health and

Human Services shall monitor the expenditures

of the Social Security Act (42 U.S.C. 1395 et seq.) 1 2 for home health services (as defined in section 3 1861(m) of such Act (42 U.S.C. 1395x(m))) for the fiscal year, including substitute adult day care serv-5 ices under paragraph (8) of such section (as added 6 by subsection (a)), and shall compare such expendi-7 tures to expenditures that the Secretary estimates would have been made for home health services for 8 9 that fiscal year if subsection (a) had not been en-10 acted.

> (2)REQUIRED REDUCTION IN PAYMENT RATE.—If the Secretary determines, after making the comparison under paragraph (1) and making such adjustments for changes in demographics and age of the Medicare beneficiary population as the Secretary determines appropriate, that expenditures for home health services under the Medicare Program, including such substitute adult day care services, exceed expenditures that would have been made under such program for home health services for a year if subsection (a) had not been enacted, then the Secretary shall adjust the rate of payment to adult day care facilities so that total expenditures for home health services under such program in a fiscal year does not exceed the Secretary's estimate of

- 3 (d) Effective Date.—The amendments made by
