A BILL

To amend title 38, United States Code, to increase the rate of special pension for recipients of the Medal of Honor and to make that special pension effective from the date of the act for which the recipient is awarded the Medal of Honor and to amend title 18, United States Code, to increase the criminal penalties associated with misuse or fraud relating to the Medal of Honor.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "Living American Hero
- 3 Appreciation Act".
- 4 SEC. 2. INCREASE IN RATE OF SPECIAL PENSION FOR
- 5 MEDAL OF HONOR RECIPIENTS AND RETRO-
- 6 ACTIVITY OF PAYMENTS TO DATE OF ACTION.
- 7 (a) Increase in Special Pension.—Section
- 8 1562(a) of title 38, United States Code, is amended by
- 9 striking "a special pension at the rate of" and all that
- 10 follows through the period at the end and inserting "a spe-
- 11 cial pension, beginning as of the first day of the first
- 12 month that begins after the date of the act for which that
- 13 person was awarded the Medal of Honor. The special pen-
- 14 sion shall be at the rate of \$1000, as increased from time
- 15 to time under section 5312(a) of this title.".
- 16 (b) Cost of Living Adjustment.—Section 5312(a)

- 18 following: "the rate of special pension paid under section
- 19 1562 of this title,".
- 20 (c) Lump Sum Payment for Existing Medal of
- 21 Honor Recipients.—The Secretary of Veterans Affairs
- 22 shall, within 60 days after the date of the enactment of
- 23 this Act, make a lump sum payment to each person who
- 24 is, immediately before the date of the enactment of this
- 25 Act, in receipt of the pension payable under section 1562
- 26 of title 38, United States Code (as amended by subsection

1	(a)). Such payment shall be in the amount equal to the
2	total amount of special pension that the person would have
3	received had the person received special pension during the
4	period beginning as of the first day of the first month that
5	began after the date of the act for which that person was
6	awarded the Medal of Honor and ending with the last day
7	of the month preceding the month that such person's spe-
8	cial pension in fact commenced. For each month of such
9	period, the amount of special pension shall be determined
10	using the rate of special pension that was in effect for
11	that month.
