A BILL

To authorize the President to award the Medal of Honor posthumously to Henry Johnson, of Albany, New York, for acts of valor during World War I and to direct the Secretary of the Army to conduct a review of military service records to determine whether certain other African American World War I veterans should be awarded the Medal of Honor for actions during that war.

- 1 Be it enacted by the Senate and House of Representa-

1 SECTION 1. SHORT TITLE.

- 2 This Act may be cited as the "World War I Veterans
- 3 Medal of Honor Justice Act".
- 4 SEC. 2. AUTHORITY FOR AWARD OF MEDAL OF HONOR TO
- 5 HENRY JOHNSON.
- 6 (a) Inapplicability of Time Limitations.—Not-
- 7 withstanding the time limitations in section 3744(b) of
- 8 title 10, United States Code, or any other time limitation,
- 9 the President may award the Medal of Honor under sec-
- 10 tion 3741 of such title posthumously to Henry Johnson
- 11 (service number 10–33–48), of Albany, New York, for the
- 12 actions referred to in subsection (b), the Secretary of the
- 13 Army having determined that by those actions Henry
- 14 Johnson distinguished himself conspicuously by gallantry
- 15 and intrepidity at the risk of his life above and beyond
- 16 the call of duty.
- 17 (b) ACTIONS.—The actions referred to in subsection
- 18 (a) are the actions of Henry Johnson during World War
- 19 I in repulsing an attack by a superior enemy force and
- 20 rescuing a badly wounded comrade, notwithstanding his
- 21 own serious wounds, on the night of May 14–15, 1918,
- 22 while serving as a private in the 369th Infantry Regiment
- 23 of the United States Army.
